Circular

Sub:- Appointment to the post of Welfare Assistant.

The post of welfare Assistant in the scale of PB-2- Rs. 9,300/- , Rs, 34,800/- in Grade pay of Rs. 4800/- is to be filled up on deputation basis on usual terms of deputation from eligible staff. The post is to be operated at Allahabad.

The conditions of eligibility are as under:-

- (a) (i) Holding analogous posts on regular basis in the parent cadre or department, or
 - (ii) With three years service in the grade rendered after appointment thereto on a regular basis in the scale of pay of PB-2, Rs. 9,300/-, Rs, 34,800/- in Grade pay of Rs, 4200/- or equivalent in the parent cadre or department and
 - (iii) Possessing 03 years experience in the field of Welfare or Community activities, House Keeping, Sports and Cultural Activities, Personal Administration including settlement of personal claims etc.
- (b) Officials with Combined regular service of three years in the grade of Senior Accountants/Senior Auditors and Assistant Supervisor (Accounts)/Assistant Supervisor (Audit) are eligible for deputation to the post of Welfare Assistant.

Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central Government shall ordinarily not exceed (03) years. The maximum age limit for appointment on deputation shall not be exceeding 56 years on the closing date of receipt of applications.

Integrity Certificate, Vigilance Clearance Certificate and APAR of last five years may also be sent alongwith the application of willing candidates.

The eligible and willing officials may apply in enclosed proforma through proper channel so as to reach to SR. Audit Officer (Admn.), Office of the Principal Director of Audit, North Central Railway, Allahabad within one month of issue of this circular.

Applications received after the prescribed date will not be entertained.

This issues with the approval of Principal Director of Audit.
