- The official can be repatriated to his/her parent office any time as per administrative convenience.
- The age of the willing officials should not exceed 56 years as on the date of issue of this
 circular.
- Deputed officials will be entitled for deputation allowance as applicable in accordance with the relevant instructions of DOPT as amended from time to time.
- Selection of candidates for deputation will be decided by the Competent Authority of this
 office. The officials will be liable to be posted any where under the cadre controlling authority of the
 office.
 - The deputation will be subject to the recruitment rules in force.
