In compliance with the instructions contained in Headquarters letter Lr. No. 1023-Staff(App.I)/04-2020/Vol-I dated 26.08.2020, applications in the enclosed proforma are invited from following officials belonging to Accountant General (A&E) offices for filling up the posts in the cadre of Assistant Audit Officer(Audit) under revised pay structure of 7th CPC (Pay Level- 8) at Vijayawada

1. Officials who have passed the SAS (Civil Audit) examination held in November, 2019
2. Officials who had passed the SAS(Civil Audit) examination held prior to November, 2019, except those who have already been promoted as AAO (Regular) in their parent cadre, and could not be absorbed in the Civil Audit offices

In order to fill **8 (Eight)** vacancies on deputation basis, it is requested to recommend the names of SAS(Civil Audit) Exam passed willing officials of your Office.

Recommendation should include the Curriculum Vitae in duplicate, service particulars of the officials (in original), copies of ACRs/APARs for the last 5 years, (each and every page of the ACRs/APARs including gap sheets, if any, should be attested), DC/VC clearance certificate, Composite statement of Cadre Clearance/Integrity Certificate/Vigilance Clearance/Major/Minor Penalty and the acceptance of the following terms and conditions by the individuals: -

1. The deputation is only temporary and does not give any right for indefinite retention of the persons in the Offices to which they have been deputed.
2. Persons selected will have no claim for posting to field duty or otherwise, which will be regulated according to need. They will also be liable to be posted to any other office of O/o Prl. Accountant General (Audit), Andhra Pradesh.
3. The Deputationists may be repatriated prematurely, if departmental candidates are available for promotion.
4. The Deputationists may be surrendered/replaced without assigning any reason, if found unsuitable. The term of deputation will be for one year at a time, extendable upto a maximum of four years.
5. The deputation is subject to other usual terms and conditions applicable to deputation within IA&AD and Govt. of India, Ministry of Personnel, vide DoPT OM No. 6-08-2009-Estt. (Pay-II) dt 17-06-2010 and OM No. 2/6/2016-Estt. (Pay-II) dated 17-02-2016 as amended from time to time

Applications of candidates who have attained age of 56 years need not be forwarded.

This office will entertain the applications received through proper channel only.
