Applications are hereby invited for appointment to the posts of Assistant Accounts Officer on deputation basis in this office on the terms and conditions laid down in DoPT O.M. No. 2/6/2016-Estt. (Pay-II) dated 17/02/2016 read with DoPT O.M. No. 6/8/2009-Estt. (Pay II) dated 17/06/2010 as well as other guidelines issued in this regard from time to time.

2. The eligibility criteria for appointment to the said post are as under:-

Name of the Post	Eligibility
Assistant Accounts Officer	(i) Officers under the Cadre Controlling Authority in the Indian Audit and Accounts Department or in any Organized Accounts Cadre under the Government of India holding analogous posts of Assistant Accounts Officer or Assistant Audit Officer in Pay Band -2, Pay Scale of Rs. 9300- 34800 with Grade Pay of Rs. 4800/- (alongwith officers who have been granted NFU) (ii) The maximum age limit for appointment by deputation shall not be exceeding 56 (fifty-six) years as on the closing date of receipt of applications.

3. The period of deputation shall initially be for one year, further extendable on yearly basis, subject to performance of the Officer and availability of vacancy as per rule.


4. In this regard, it is requested to kindly recommend the names of eligible officers who are willing and can be spared immediately in the event of their selection for the above post of Assistant

Accounts Officer on deputation basis. The recommendations accompanied with the following documents/certificates may kindly be forwarded to this office within 30 days of issue of this circular.
