ESSENTIAL QUALIFICATION

1. SENIOR AUDIT OFFICER/SENIOR ACCOUNTS OFFICER holding analogous post on a regular basis for minimum period of two years.
2. Prior experience in using PFMS / iBEMS/GeM/GST module is desired.
3. Experience in Administration, Office Management are also desired.
4. Working experience as Drawing and Disbursing Officer and in Regional Training Institute is desired
5. Candidates without the desirable qualification in Sl No.2 ,3 and 4 can also apply.
6. The selected Officer will be eligible for deputation allowance as per extant orders issued from time to time.
7. Applicant should not have crossed the age of 56 years on the closing date for receipt of applications.(ie., 21-08-2023)
8. Working knowledge in Hindi.

Names of SAOs who are willing to be considered for deputation to RTI, Chennai and fulfilling the eligibility criteria may be forwarded along with their bio-data, experience and grading of APAR for the last five years i.e., from 2017-18 to 2021-22 on or before 21-08-2023. The term of deputation will be initially for a period of three years.
