**Subject: Nomination of Sr. AOs/ AAOs for the post of 'Specialist' in State Audit Institution – Oman.**

**Sir/Madam,**

State Audit Institution, Oman has requested to nominate 'Specialists' for the following posts on secondment basis, for a period of 2 years:

2. It has been decided to nominate Sr.AOs/ AAOs as 'Specialist' for the above assignment. I am, therefore, directed to request you to recommend names of eligible Sr.AOs/ AAOs from your Office, who satisfy the following eligibility criteria:

### General Qualifications and Experience:

- **Audit Specialization:** Performance Audit, Value for Money Audit and Financial Audit
- **Qualifications:** Bachelor of Commerce, Accounting, Finance (Essential) with Professional Qualifications, CA/ ICWA/ CMA/ ACS/ CFA (Preferred) – Except for IT Audit
- **Age:** Below 50 years, as on 1st January 2024
- **Experience:** Minimum 15 years' total experience for field audit and 8-10 years shall be for the audit of specific individual sector companies or with specific field specialization
- **Role and Responsibility:** Responsible for working with audit teams as Audit 'Specialists' and provide day-to day on the job training to the SAI Oman Staff. 'Specialists' will be assigned to audit companies and entities and would be rotated based on administrative requirements. Audit assignments include companies, authorities and entities in different sectors, viz. Oil & Gas Upstream & Downstream, Airlines, Telecom, Power/ Electricity, Ports & Airports, Tourism, Shipping, Water Supply & Waste Management, Mining & Minerals, Manufacturing, Transportation, Environment & Agriculture, Investments, Capital Market, Regulatory Authorities, IT, Pension Fund Sovereign Wealth Funds, etc.
- **Desirable Criteria**
  - Expertise in complete audit process from Risk Assessment Stage, Audit Planning, Audit Execution in the Fields, Audit Reporting and Follow-up.
  - Expertise in Performance Audit, Value for Money Audit and Financial Audit.
  - Expertise in carrying out audit in computerized environment, including SAP System.
  - Technical knowledge of the activities carried-out by the companies and entities in sectors specified by SAI Oman.
  - Familiarization of accounting systems and related procedures used in performance of financial operations by the companies in sectors specified by SAI Oman.
  - Ability to analyse and verify correctness of financial statements and ensure their being free of accounting and technical errors.
  - Full knowledge of applicable International Financial Reporting and Auditing Standards with ability to apply relevant audit standards and guidance in field audit.
  - Full Knowledge of audit of Annual Financial Statements and the Accounting Policies & Practices followed by the companies in sectors specified by SAI Oman.
  - Excellent knowledge of .Microsoft Office & IT Tools and proficiency in data analysis.
- **Communication Criteria:** Excellent communication skills, with ability to present, discuss and at times defend views effectively through formal, informal, written and spoken communication.
- The Officer should have 'Outstanding' APARs for the last five years i.e. 2018-19 to 2022-23.

- Officers who had earlier done foreign assignment/ foreign posting should not be recommended.
- In case of selection, the selected Officer will be required to work in the Headquarters at New Delhi for a period of three years, on return from the assignment.
- The Sr.AO/ AAO should not expect, in normal course, promotion to the next grade in the next 3 years. A certificate to this effect may be furnished at the time of recommending the names.
- The nominated Officers should be clear from vigilance angle. A certificate to this effect may be furnished.

  - Full knowledge of SAP system used by companies in upstream Oil and Gas Sector.
  - Full knowledge of Financial Statements and Recoverable Cost Statements prepared by Operators under Production Sharing Agreements.
  - Experienced for field audit of projects executed and facilities maintained for Renewable Energy and Green Hydrogen by companies in this sector (preferred).
- **Specialist: Mid & Downstream Oil & Gas and Minerals Sector**
  - Experienced for field audit of the Refineries in Midstream Oil & Gas Sector.
  - Experienced for field audit of projects executed and plants and facilities maintained by companies in Mid & Downstream Oil & Gas sector and for development & extraction under Mining & Minerals Sector.
  - Experienced for audit of contracts executed by companies in Mid & Downstream Oil & Gas and Mining & Minerals Sector for obtaining capital goods, materials & services.

## Emoluments and Perks:

- The selected 'Specialists' would be entitled for Emoluments and Perks as follows:
- Consolidated Emoluments of Omani Rials 1600 per month (1 Omani Rial= 2.5954 USD).
- Annual increment of Omani Rials 30, as per rules.
- Furniture allowance of Omani Rials 2000 upon joining.
- Dependent family members will be allowed to join immediately and the Officer and dependent family members will be paid business class air fare passage on joining SAI Oman and on completion of service.
- Annual leave for 48 days.
- Free medical attention in Government Hospital/Clinic, provided locally for self and approved dependents.
- End of service benefits, as per Government rules.
- There is no personal Income tax in Oman, at present.
- All the above conditions are subject to Government of Oman's Personnel Law & Regulations.

3. Principal Accountants General/ Directors General of Audit/ Accountants General/ Principal Directors of Audit/ Director General (Hqrs), may review the cases of all willing and eligible Officers and recommend the names. It must be ensured that Officers recommended are suitable in terms of above criteria.

4. The recommendations along with service and other particulars of the candidates in the enclosed proforma (**Annexure - I**), in duplicate, may be sent to the undersigned **latest by 23.02.2024**.

5. The photocopy of the APARs are not required to be sent at this stage. However, the abstracts of APARs for the last five years from i.e. 2018-19 to 2022-23 in the prescribed proforma (**Annexure - II**) duly certified by the Sr.DAG/ Director/ DAG/ Dy. Director (Admn.)/ Dir. (P), may be sent to the undersigned along with the recommendation.

6. Officers who are willing to apply for more than one Specialist post, may send separate bio-data for each post.

7. All applications (except those working on deputation in HQ) must be routed through the respective Cadre Controlling Authority (CCA). In respect of officers working on deputation in HQ, names may be recommended locally through DG (Hqrs), with intimation to their respective CCAs. CCAs may also recommend names of Officers who are on deputation to other offices of the IA&AD and HQ, but not those who are presently on deputation outside IA&AD.

8. Officers who have returned from deputation from outside the Department must have completed the mandatory period of cooling off in terms of DoPT instructions.

9. A 'NIL' recommendation may be sent where there are no suitable candidates.

10. Recommendations in respect of officers of Commercial cadre may be sent to DG (Commercial) in Headquarters for final recommendation.
