

### Functions of Standing Committees

#### (a) Standing Committees in GPs

- (i) *Niyojan Evam Vikas Samiti*: is responsible for preparing development plan for GP and implementation of Agriculture, Animal Husbandry and Poverty Alleviation schemes.
- (ii) *Shiksha Samiti*: is responsible for implementation of schemes related to primary education, adult & informal education and literacy programme.
- (iii) *Nirman Karya Samiti*: is responsible for all construction and maintenance works and quality thereof.
- (iv) *Swasthya Evam Kalyan Samiti*: is enshrined with the task of Medical, Health, Family Planning and Social Welfare Schemes especially for implementation of Women and Child Welfare Schemes.
- (v) *Prashasanik Samiti*: deals with matters related to establishment of employees and fair price shop of Gram Panchayat.
- (vi) *Jal Prabandhan Samiti*: deals with operation and maintenance of Drinking Water Scheme and Tube wells.

#### (b) Standing Committees in ZPs/KPs

- (i) *Niyojan Evam Vikas Samiti*: is assigned the task to prepare a plan for GPs and to implement the Agriculture, Animal Husbandry and Poverty Alleviation schemes.
- (ii) *Shiksha Samiti*: is assigned the task regarding Primary Education, Upper Primary Education, Informal Education and Literacy Programme.
- (iii) *Nirman Karya Samiti*: is entrusted with the task to have effective control and quality assurance in all the temporary and permanent constructions and maintenance works.
- (iv) *Swasthya Evam Kalyan Samiti*: is responsible for implementation of Medical, Health and Family Welfare schemes.
- (v) *Prashasanik Samiti*: is responsible for all the subjects of personnel engaged under the control of GPs and works related to fair price shops.
- (vi) *Jal Prabandhan Samiti*: is responsible for operation and maintenance of tube wells and operation of schemes regarding drinking water.

#### Components of TSC/NBA

Sl. No.	Component	Description
1.	Start-Up Activities	Under this component preliminary survey, baseline survey, orientation of key personnel and preparation of State Plan were to be done.
2.	Information, Education and Communication activities	A CCDU was to be set up at the State level to support districts in developing a good IEC plan and implementing it. State level HRD activities were also to be done.
3.	Capacity Building	This component was related to training of VWSC and PRI members, block and district and grass root functionaries.
4.	Construction of Individual Household Latrines	Construction of the IHHL was to be undertaken by the household itself and on completion and usage of the IHHL, a cash incentive was to be given to the BPL household in recognition of its achievement. The Incentive was extended to APL households restricted to SCs/STs, small and marginal farmers, landless labourers with homestead, physically handicapped and women headed households.
5.	Rural Sanitary Marts (RSMs) and Production Centers (PCs):	The RSM was an outlet dealing with materials, hardware and designs required for construction of sanitary latrines, soakage and compost pits, vermi-composting, washing platforms and other sanitation & hygiene accessories. PCs were meant to produce cost effective affordable sanitary materials at the local level. They could be independent or part of the RSMs.
6.	Provision of Revolving Fund in the District	Five <i>per cent</i> of the district project outlay subject to a limit of ₹ 50 Lakh was provisioned as revolving fund. Loan given from this fund was to be recovered in 12-18 instalments.
7.	Community Sanitary Complex	Community Sanitary Complex was an integral component of NBA. These Complexes, comprising of an appropriate number of toilet seats, bathing cubicles, washing platforms, wash basins etc. were to be set up in a place in the village which was acceptable and accessible to all.
8.	Institutional Toilets	Toilets in all types of Government Schools were to be constructed. Emphasis was to be given to toilets for girls in schools. Likewise <i>Anganwadis</i> in Government buildings were to be provided with a baby friendly toilet.
9.	Solid and Liquid Waste Management	Projects were to be prioritized in identified GPs targeted for <i>Nirmal</i> status. The assistance for SLWM projects was based on number of households in GPs, subject to a maximum of ₹ 7 lakh for a GP having up to 150 households, ₹ 12 lakh up to 300 households, ₹ 15 lakh up to 500 households and ₹ 20 lakh for GPs having more than 500 households.
10.	Maintenance of facilities created under NBA	It was essential to train the rural community, particularly all the members of the family about proper upkeep and maintenance of the sanitation facilities created.
11.	Administrative Charges	The Administrative Charges included money spent on salary of temporary staff deployed for the execution of TSC/NBA, support services, fuel charges, vehicle hire charges, stationery, monitoring and evaluation of NBA project. It was to be up to four <i>per cent</i> of the total district project outlay of TSC/NBA.
