## Summary of the International Workshop on Biodiversity with special reference to forest resources from 03<sup>rd</sup> to 07<sup>th</sup> February 2025

International Centre for Environment Audit & Sustainable Development (iCED), as the Global Training Facility (GTF) of INTOSAI Working Group on Environmental Auditing (WGEA), organised International Workshop on 'Biodiversity with special reference to forest resources from 03rd to 07th February 2025 in onsite mode at iCED. A total of 09 participants from 07 SAIs participated in the workshop.

In his welcome address, Mr. Mehul Grover, Director, (Training & Research), iCED extended his greetings to Dr. Abhishek Gupta, Director General of iCED as well as to the participants.

Dr. Abhishek Gupta, Director General of iCED, in his inaugural address, highlighted the importance of biodiversity for sustaining life on Earth. He noted the growing significance of forest conservation, emphasizing the positive trend of increased forest cover and the expansion of protected areas. This progress, coupled with adherence to international commitments and the execution of focused conservation initiatives, reflects a proactive approach toward safeguarding global biodiversity.

He stressed that constant vigilance and unwavering commitment are essential to maintaining ecological balance and preserving our natural heritage for the generations to come.

He also addressed the challenges faced by countries globally in developing their forest sectors. These obstacles stem from weaknesses in institutional frameworks, a lack of effective policies to promote afforestation and social forestry programs, and financial difficulties. These issues

highlight the need for Supreme Audit Institutions (SAIs) to step up and focus on the forestry sector.

Furthermore, he emphasized the importance of SAIs in establishing a comprehensive auditing framework, which will help governments and stakeholders drive the development of this sector and he urged audit professionals to stay informed about the latest advancements, stressing their role in aligning innovation with responsibility.

He also shared details about a range of outdoor activities designed to enhance participants' connection with the environment and India's rich cultural heritage. He mentioned visits to iconic destinations such as the Taj Mahal in Agra and Chokhi Dhani in Jaipur. These excursions aim to offer participants a unique opportunity to experience firsthand the beauty of India's natural landscapes and historical monuments, fostering a deeper understanding of the importance of environmental preservation while also immersing them in the country's vibrant cultural traditions.

The inaugural addresses were concluded with expressions of gratitude to Mr. Sami Yläoutinen, Chair of the INTOSAI Working Group on Environmental Auditing and Auditor General of the National Audit Office of Finland, and his team for their support in organizing the workshop. Special thanks were also extended to all the SAIs for nominating participants and SAI Finland and Maldives to contribute trainers to the workshop. The address ended by welcoming all participants and guest faculties.

During the workshop, experts from SAI Finland, SAI Maldives, SAI India, and other prestigious institutions shared their insights through relevant case studies, providing a comprehensive understanding of various aspects of Biodiversity Auditing. The session-wise details are outlined below:
