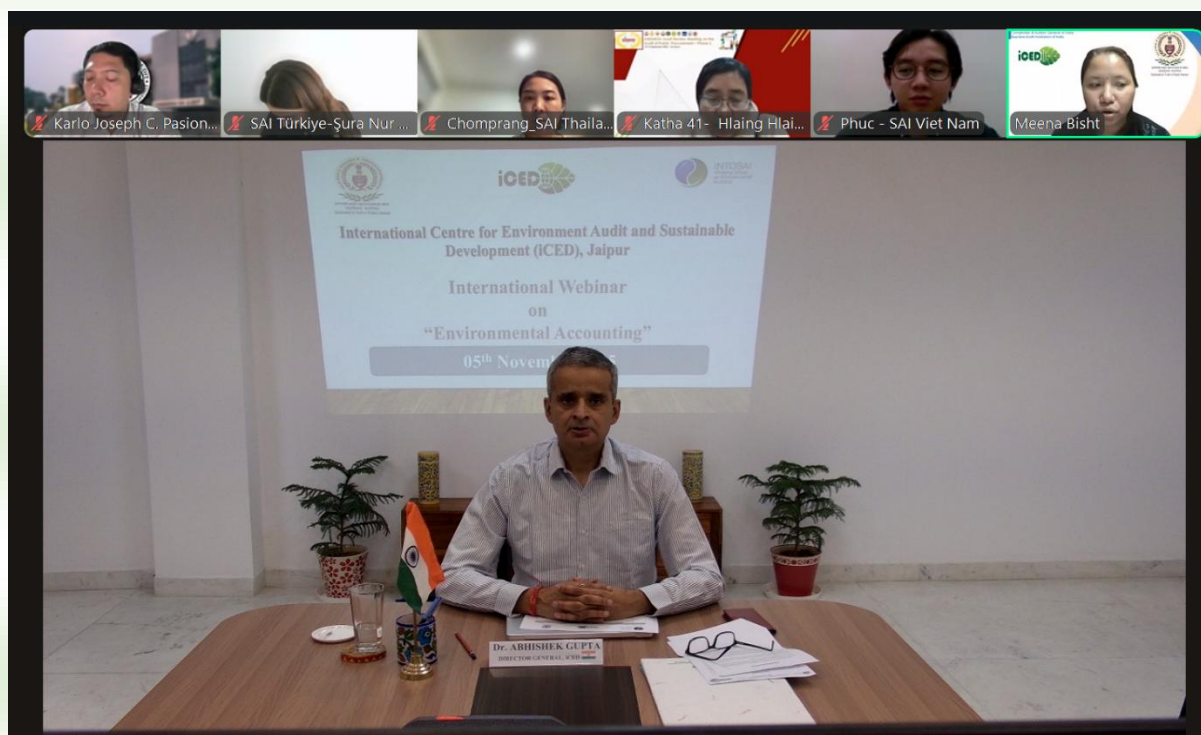


International Webinar on “Environmental Accounting” on 05th November 2025
