Ms. Meena Bisht, Director (Training & Research), iCED, in her welcome address, extended her greetings to Dr. Abhishek Gupta, Director General, iCED, Shri Harish Khurana, Dy. Director (Admn.), iCED, Ms. Pushpalata, Director, NAAA and all the trainees of the 2024 batch of the Indian Audit and Accounts Service including one (01) officer from the Royal Audit Authority of Bhutan.

In his opening remarks, Dr. Abhishek Gupta, Director General, iCED, warmly acknowledged the distinguished presence of the officer trainees. Setting a positive tone for the proceedings, he noted that environmental concerns in India span across all natural resources. He emphasized that auditors must try to deliver evidence-based reports with constructive recommendations to ensure accountability, drive corrective action, and uphold their responsibility to conserve the environment.

He emphasised that while the department has undertaken audits in various areas such as pollution, waste management, biodiversity, and forests etc. the fragmented responsibilities and systemic complexities make it imperative to develop sharper skills and adopt advanced techniques for auditing this dynamic domain.

He highlighted that iCED with its recent recognition as a Centre of Excellence on Audit of the Blue Economy, continues to strengthen global capacity in environmental auditing and sustainable development.

He further informed that, alongside classroom sessions, the programme has been designed to include a series of enriching field activities to provide practical insights. These featured an excursion to the historical places of Jaipur along with field attachments with forest department at Udaipur including a visit to Sajjangarh Biological Park and Badal Mahal. Further, it also included visit to recently recognised Ramsar wetland site at 'Menar' wetland in collaboration with state wetland authority. Further as a part of public outreach activity, an interaction at the prominent Udaipur based NGO "Sewa Mandir" was also arranged to understand their working areas.

Five classroom sessions at iCED were enriched by the contributions of four IA&AS Officers and an expert from Malaviya National Institute of Technology (MNIT), Jaipur. Details of the trainers and the sessions delivered during this programme are as follows:
