

The undersigned is directed to inform that the rate of "Festival Grant" for the Financial Year 2025-26 for various categories of employees / staff / workers shall be as shown in the below table:

2.	Group – D (including employees recruited on Fixed Pay basis by keeping in abeyance the regular scale posts)	
3.	DRWs who have been engaged with prior concurrence of Finance Department	Rs. 2,100/-
4.	PTWs/Contractual Workers/Casual Workers etc. who are engaged with prior concurrence of Finance Department (The copy of concurrence to be enclosed with the bill).	Rs. 2,310/-
5.	Pensioners / Family Pensioners	Rs. 2,100/-
6.	Anganwadi Workers / Helpers	Rs. 2,310/-
7.	Home Guards / SPOs	Rs. 2,310/-
8.	Priests of Government run Temples	Rs. 2,100/-
9.	Part Time / Irregular Pump Operators under PWD(DWS) Department	Rs. 1050/-
10.	Part Time Pump Operators under RD (Panchayat)) Department	Rs. 1050/-

- 2. Regarding Workers/ Staff engaged under Central Scheme, the concerned Departments may decide.
- 3. An employee can avail the festival grant only once in any financial year and only in a single installment and for a single festival only.

4. An employee can take festival grant on the occasion of any one of the following festivals:-

i. Durga Puja

vi. Bengali New Year

ii. Christmas

vii. Eid - UI- Fitre

iii. Garia Puja

viii. Guru Nanak's Birthday

iv. Buddha Purnima

ix. Mahavir Jayanti

v. Eid-Uz-Zuha

- 5. The rate of Festival Advance and terms & conditions for Festival Advance will be as laid in the Memo issued vide No.F.10(51)-FIN(EXP-II)/63(L)/158-307, dated 21st September, 2023.
- 6. DDO has to satisfy by certifying that concerned employee under his / her jurisdiction has not availed Festival Grant / Festival Advance more than one occasion in a Financial Year and the entire amount of advance taken earlier has been paid back to the State exchequer.
- 7. Administrative Department do not need to send any proposal separately to Finance Department for grant of Festival Advance / Festival Grant to any category of employees, which does not fit in the categories as mentioned in this memorandum.
- 8. The order shall come into force with immediate effect and remain in force until further order.
- 9. This is in supersession of all earlier orders in this regard .


