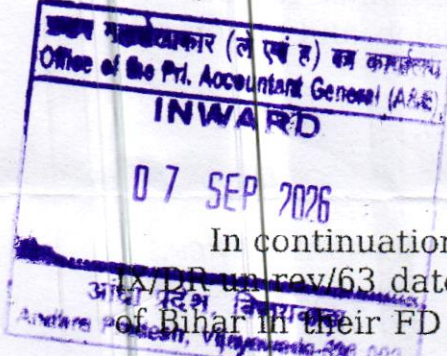

Subject : Grant of Dearness Relief to the Bihar Government pensioners/family pensioners on their pre-revised pension/family pension with effect from 01-07-2025 and 01-01-2026.

In continuation to this office circular No. Pen. Co-ordn./Bihar/Vol.- IX/DR-un-rev/63 dated 03-09-2025, this is to state that the Government of Bihar in their FD Resolution Nos. 3A-3-Allowance-02/2022-12720/B. dated 15-12-2025 and 3A-3-Allowance-02/2022-4551/B. dated 14-05-2026 has sanctioned dearness relief to their pensioners/family pensioners whose pension have been revised in the light of Bihar Government FD Resolution No. B-27/Pay Co.-137/2008-819 and 820 both dated 23-09-2009 (this office circular No. Pen. Co-ordn./Bihar/Vol.- VIII/Revision/185 dated 18-03-2010) at the rate and from the date as under :-

Date of effect	Rate of Dearness Relief per month
01-07-2025	257% of basic pension/family pension
01-01-2026	262% of basic pension/family pension

2. Payment of dearness relief involving fraction of 50 paise and above may be rounded off to the next higher rupee and fraction less than 50 paise may be ignored.

3. Dearness relief will be calculated on the sum of pay band and grade pay of the unrevised pay scale received and Special Pay or Personal Pay shall not be included in it.

4. So far as application of this order in respect of the retired employees of the High Court/Bihar Legislative Assembly/Bihar Legislative Council is concerned, necessary orders will be issued separately by the respective secretariat/office after obtaining the concurrence of the Chief Justice, Patna High Court/Speaker, Bihar Legislative Assembly/Chairman, Bihar Legislative Council, Bihar, Patna.

5. Incidentally, it may be mentioned that this circular is issued to other Accountants General just to remind them the applicability of this order to the West Bengal Government pensioners/family pensioners guided by Bihar Pension Rules.

6. Having been authorised by the Accountant General (A&E), Bihar in their authority No. PEN-09-/26-27/298 dated 10-07-2026, it is requested to make necessary arrangement for payment of dearness relief @ 257% and 262% with effect from 01-07-2025 and 01-01-2026 respectively to all eligible Bihar Government pensioners/family
