Sub:Sanction of Additional quantum of Pension/Family Pension to Pensioners /Family Pensioners of Tamilnadu State.

Ref: 1. The Principal Accountant General , Tamilnadu, Chennai, SSA.No. Pen 29/V/2011-12/88761 dt.11/08/2011.

2. GO No. 42, dated.07-02-2011, Finance (Pension) Department, Govt. of Tamilnadu.

The Government of Tamilnadu in their order cited, have ordered to sanction of additional quantum of pension/family pension to the Pensioners/Family Pensioners aged 80 Years and above as follows:

	Age of Pensioner/Family Pensioner	Additional Pension/Family Pension
1	From 80 years to 84 years	20% on basic pension/family pension.
2	From 85 years to 89 years	30% on basic pension/family pension.
3	From 90 years to 94 years	40% on basic pension/family pension.
4	From 95 years to 99 years	50% on basic pension/family pension
5	100 years and above	100% on basic pension/family pension

- I. The following procedure shall be followed while sectioning an additional quantum of pension/family pension.
 - 1. The amount of additional pension/family pension shall be shown distinctly
 - 2. Additional pension/family pension shall be taken into account for calculation of DA
 - 3.Additional pension/family pension shall be sanctioned with monetary benefit from 1-1-2011.

4.Additional pension/family pension to the pensioner/family pensioner be sectioned from the first day of the month in which he/she completes the age of 80 / 85 / 90 / 95 / 100 years or from 1-1-2011, whichever is later.

- II. These orders shall apply to the following categories of pensioners/family pensioners.
 - 1. Tamil Nadu Govt. pensioners/family pensioners.
 - 2. Teacher pensioners/family pensioners of Govt. Aided and local body educational institutions.
 - 3. Other pensioners/family pensioners of Local Bodies.
 - 4. Pensioners/family pensioners who had worked under University Grants Commission/ All India Council for Technical education/ Indian council of Agricultural Research Scale of Pay and retired.
- III. The PPO shall be the basic document for verifying the date of birth and the age of a pensioner/family pensioner. In cases where PPO is not available or the age and date of Birth of the pensioner/family pensioner has not been indicated in the PPO, those pensioners/family pensioners on completion of 80 years and above shall submit any one of the following documents to the pension disbursing officer as proof of their date of birth/age.
 - 1. PAN (Permanent Account Number) Card
 - 2. Secondary School Leaving Certificate (SSLC)
 - 3. Passport
 - 4. Driving License, if the date of birth is indicated therein
 - 5. Voters Identity Card issued by the Election Commission of India.

On receipt of any one of the above documents, the Disbursing officer shall sent the copy of the document to the authority who has pension/family pension proposals for confirming the date of birth and age of the pensioner/family pensioner. Pension/family pension shall be paid on provisional basis till the age is confirmed for six months from the date of submission of the above documents or till 30-9-2011 which ever is later.

You are hereby authorized to make payment accordingly. Expenditure may be debited 8793/ISS/Karnataka Fraction of rupee shall be rounded of to the next higher rupee. A copy of this letter may be exhibited on the notice board of the treasury.
