Subject: - Release of arrears of Dearness Allowance/Dearness relief w.e.f. 1.7.2014 to 28.2.2015 @ 7% and 1.1.2014 to 30.9.2014 @ 10% to the Punjab Government Employees and Pensioners-regarding.

Sir,

I am directed to refer to this Department's Letter No. 3/2/97-1FP1/976 dated 14.10.2014 and No. 3/2/97-1FP1/259 dated 20.3.2015 on the subject cited above and to convey that the Governor of Punjab is pleased to release the arrears of Dearness Allowance/Dearness relief w.e.f. 1.7.2014 to 28.2.2015 @ 7% and 1.1.2014 to 30.9.2014 @ 10% to the Punjab Government Employees and Pensioners. The said arrears shall be paid in cash to the employees/pensioners as under:-

- i) 50% of the arrears from 1.7.2014 to 28.2.2015 @ 7% shall be paid during the second quarter of financial year 2016-2017 i.e. from 1.7.2016 to 30.9.2016
- ii) 50% of the arrears from 1.7.2014 to 28.2.2015 @ 7% shall be paid during the third quarter of financial year 2016-17 i.e. from 1.10.16 to 31.12.2016.
- iii) 50% of the arrears due from 1.1.2014 to 30.9.2014 @ 10% shall be paid during the fourth quarter of financial year i.e. from 1.1.2017 to 31.3.2017
- iv) 50% of the arrears due from 1.1.2014 to 30.9.2014 @ 10% shall be paid during the first quarter of financial year 2017-2018 i.e. from 1.4.2017 to 30.6.2017.
