Sub :- Revision of pension of pre 01.01.2006 Government Pensioners in view of the recommendations of Sixth Pay Commission – reg.

Sir,

As directed, it is to inform on the above subject that many applications are received to this department from pre 01.01.2006 government pensioners for the consolidated guidelines regarding revision of pension/family pension. It is mentioned therein that there is practical difficulty in the fixation of pension/ family pension of pre 01.01.2006 pensioners in view of the recommendations of sixth pay commission.

After due consideration, in view of Finance Department Resolution No. 660/Fin. dated 28.02.2009 & Resolution No. 858 dated 27.03.2015 it is clarified that the revision of pension/family pension of pre 01.01.2006 pensioners in view of the recommendations of sixth pay commission shall be as follows:-

(i) The calculation table of pension/family pension fixed in view of para 4.1 of letter no. 38/37/08 P&PW(A) dated 01.09.2008 of Ministry of Personnel, Public Grievances & Pension (Department of Pension & Pensioners' Welfare), is as follows:-

(Part A) (Ready Reckoner is attached as Annexure-I to the letter cited)

(ii) The calculation table of pension/family pension fixed in view of letter no. 38/37/08 P&PW(A) dated 27.03.2005 of Ministry of Public Grievances and Pension (Department of Pension & Pensioners' Welfare), Government of India enclosed with Finance Department, Jharkhand Resolution no. 858/Fin. (Pay scale based relevant table is enclosed with the above letter, which has been prepared considering those government servants, who have retired after completing maximum period of service (33 years) permissible), is as follows:-(Part B)

Pension

(A) 30% of the minimum of pay in the pay band + Grade Pay corresponding to the pre-revised pay scale.

(A) 50% of the minimum of pay in the Pay band + Grade Pay corresponding to the Pre-revised pay scale.

(B) Qualifying service (Maximum of 33 Years)

(C) Pension =  $(A) \times (B)$ 

(B) Family Pension = (A)

[Earlier in Para A of the above calculation table there was provision of 50%/30% of the Minimum of pay band, which has been replaced by the provision of 50%/30% of the Minimum of pay in the pay band only]

- (iii) Maximum of pension/family pension fixed as in above mentioned para (i) or para (ii) shall be the revised pension/family pension.
- (iv) Pension of pre 01.01.2006 retired government servants shall not be less than 50% of the sum of minimum of pay in the pay band and grade pay corresponding to the pre revised scale of pay from which the pensioner had retired and not 50% of the sum of pay in the pay band and grade pay of replaced scale of pay in which the pensioner had retired.

Example:-

(A) If any government servant has retired before 01.01.2006 in the scale of pay of 5000-150-8000 with basic pay of ₹ 6500 after completing 30 years of service:-

Pension (Part A) according to Para (i) = 6679 Pension (Part B) according to Para (ii) = 6136 Hence Revised Pension = 6679

(B) If any government servant has retired before 01.01.2006 in the scale of pay of 5000-150-8000 with basic pay of ₹ 5000 after completing 33 years of service :-

Pension (Part A) according to Para (i) = 5650 Pension (Part B) according to Para (ii) = 6750 Hence Revised Pension = 6750

(C) If any government servant has retired before 01.01.2006 in the scale of pay of 5500-175-9000 with basic pay of ₹ 5850 after completing 25 years of service:-

Pension (Part B) according to Para (ii) = 5466 Hence Revised Pension = 5466 (D) If any government servant has retired before 01.01.2006 in the scale of pay of 6500-200-10500 with basic pay of ₹ 6900 after completing 33 years of service:

Pension (Part A) according to Para (i) = 7797 Pension (Part B) according to Para (ii) = 8145 Hence Revised Pension = 8145

(E) If any government servant has retired before 01.01.2006 in the scale of pay of 6500-200-10500 with basic pay of ₹ 6900 after completing 20 years of service:-

Pension (Part A) according to Para (i) = 4727 Pension (Part B) according to Para (ii) = 4936 Hence Revised Pension = 4936

(F) Revision of pension of retired government servants with less than 20 years of service shall also be done accordingly.
