CIRCULAR -89

Subject: Annual General Transfers-2026 – Options for stations for Transfer.

As per the guidelines issued by the Headquarters office, the DA Cadre officials listed in Annexure-I are due for transfer this year. Accordingly, these officials are required to submit their preferences, in order of priority, for maximum number of 10 stations with appropriately graded vacant divisions from the provided list.

While submitting the options, the following factors must be considered:

1. Transfers and postings of DA Cadre officials will be carried out in accordance with the guidelines, circulars, and classifications issued by the Headquarters office and this office from time to time.
2. Stations opted for by the officials will be considered subject to vacancy availability, relevant guidelines, and administrative exigencies.
3. If an appropriate division is not available in the opted stations, a nearby station may be considered for transfer and posting.
4. Options received after the due date and time will not be considered, and postings will be decided based on the availability of vacancies.
5. Transfers and postings will be allocated to appropriately graded divisions based on factors such as average annual expenditure, nature of work, territorial jurisdiction, performance of the officer, geographic distribution of officials, and administrative requirements.
6. Adverse remarks against the official, if any, from inspecting Officers auditing divisional accounts, Reporting Officers (such as Executive Engineers/Superintending Engineers) in Annual Performance Appraisal Reports, provided such remarks are accepted by Reviewing Officers, Performance in timely submission of accounts, and Verified complaint cases supported by evidence, etc., will be considered when deciding postings and transfers.
7. If an official due for transfer upon completing three years in a division opts for another station as their first choice, it will be considered as their willingness to be transferred from the current station. However, all options (same or different stations) will be assessed based on the criteria mentioned in Point No. 5 above.
8. Options for stations shall be submitted by the concerned officials in

accordance with their grade **prevailing** at the time of submission of options.

Officials must submit their options only through official email IDs to the office email ID agaemaharashtra2@cag.gov.in, with a copy to the official email ID of the Sr. Deputy Accountant General (Works Accounts) dagaccounts.mh2.ae@cag.gov.in, by **04:00 pm** on or before **20/05/2026**. Options received after the due date will not be considered, and postings will be determined based on vacancy availability.

A list of vacant divisions, along with divisions likely to fall vacant and their respective grades, has been published on the office website to assist officials in selecting their preferred stations for the Annual General Transfers 2026.
