It has been come to the notice that some Pay Band / Scale remained to be included in Annexure – IV of the said GR.

Resolution:

After careful consideration, the state Government is pleased to replace the Annexure – IV as enclosed herewith. Further below mentioned provision of the Government Resolution dated 26/2/14 stands cancelled.

"As mentioned in the Para 9.2 of the Government Resolution dated 13-4-2009, the provisions of Para 3 of the Government Resolution dated 1-11-2000 i.e. pay scale of the post last held and corresponding pay scale shall

only to be taken into consideration, the Senior Scale, Selection Scale or Higher Pay Scale shall not be considered." The provisions of the GR dated 12/3/18 shall be followed.
