राज्य सरकार के पेंशन/पारिवारिक पेंशनभोगियों को अपुनरीक्षित वेतनमान (छठा केन्द्रीय वेतनमान) में विनांक 01.07.2017 के प्रभाव से महँगाई राहत की वरों में अभिवृद्धि के संबंध में।

वित्त विभाग के संकल्प संख्या 660/वि•, दिनांक 28.02.2009 के द्वारा राज्य सरकार के पेंशनधारियों/पारिवारिक पेंशनभोगियों की केन्द्र सरकार के पेंशनधारियों/पारिवारिक पेंशनभोगियों की भांति दिनांक 0 .01.2006 के प्रभाव से अपुनरीक्षित (छटा वेतनमान) केन्द्रीय पेंशन/पारिवारिक पेंशन की रवीकृति प्रदान की गई है। उक्त संकल्प की कंडिका—17 (ए०)(बी०) के अनुसार पेंशनधारियों/पारिवारिक पेंशनभोगियों को केन्द्रीय दर पर महँगाई राहत स्वीकृत किया गया है

- 2. उपर्युक्त के अनुसार केन्द्र सरकार के पेंशनभोगियों के भांति दिनांक 01.01.2017 से राज्य सरकार के पेंशनधारियों / पारिवारिक पेंशनभोगियों को भी महँगाई राहत अनुमान्य किया जाता है। वर्तमान में राज्य सरकार के पेंशनधारियों / पारिवारिक पेंशनभोगी, जो अपुनशिक्षत वेतनमान (छठा वेतनमान) में पेंशन प्राप्त कर रहे हैं, को 136% (एक स्मै छत्तीस प्रतिशत) महँगाई राहत अनुमान्य है।
- 3. केन्द्र सरकार के द्वारा अपने कर्मियों को दिनांक 01.07.2017 के प्रभाव से छठे वेतन पुनरीक्षण के लाभ के अनुरूप महँगाई भत्ते का पुनरीक्षण किया गया है और उसके आलोक में भारत सरकार के वित्त मंत्रालय (व्यय) के पत्र संख्या 1/3/2008 E.II(B) दिनांक 26.09.2017 के प्रभाव से छठे अपुनरीक्षित वेतनमान में महँगाई भत्ते की दर को 136% (एक सौ छत्तीस प्रतिशत) से बढ़ाकर 139% (एक सौ उनचालीस प्रतिशत) स्वीकृत किया गया है।
- 4. केन्द्र सरकार के उक्त निर्णय को दृष्टिपथ में रखते हुए राज्य सरकार द्वारा सम्यक् विचारोपरांत राज्य के पेंशनधारियों / पारिवारिक पेंशनभोगियों को, जो अपुनरीक्षित वेतनमान (छठा वेतनमान) में पेंशन प्राप्त कर रहे हैं, को दिनांक 01.07.2017 के प्रभाव से महँगाई राहत 136% (एक सौ छत्तीस प्रतिशत) से बढ़ाकर 139% (एक सौ उनचालीस प्रतिशत) किये जाने का निर्णय लिया गया है।
- 5. प्रस्ताव पर मंत्रिपरिषद् की स्वीकृति वित्त विभागीय संलेख ज्ञापांक 3581/वि० दिनांक 07.11.2017 के क्रम में दिनांक 07.11.2017 की बैठक के मद सं० 24 में दी गई है।

RESOLUTION

Sub :

Enhancement in the rates of Dearness Allowance w.e.f. 01.07.2017 to State Government pensioners/family pensioners in unrevised pay scale (Sixth Central Pay scale).

Vide Finance Department, Resolution No. 660/Fin. dated 28.02.2009, sanction of central pension/family pension has been accorded to state government pensioners/family pensioners w.e.f 01.01.2006 at par with Central Government pensioners/family pensioners. As per para-17(a)(b) of the above Resolution, dearness relief at central rate has been sanctioned to the pensioners/family pensioners.

- 2. As mentioned above, dearness relief is permitted w.e.f. 01.01.2017 to state government pensioners/family pensioners also at par with Central Government pensioners. Dearness Relief of 136% (One Hundred and Thirty Six Percent) is permitted to the state government pensioners/family pensioners receiving pension in unrevised pay scale (sixth pay scale) at present.
- 3. The dearness allowance of central government employees has been revised w.e.f. 01.07.2017 by the Central Government in accordance with the benefit of Sixth Pay Revision and in the light of the above the rate of dearness allowance in sixth unrevised pay scale has been increased from 136% (One Hundred and Thirty Six Percent) to 139% (One Hundred and Thirty Nine Percent) vide Government of India, Finance Department (Exp.) letter no 1/3/2008 EII(B) dated 26.09.2017.
- 4. Keeping in view the above decision of the Central Government, the state government after due consideration have decided to enhance the dearness relief of their pensioners/family pensioners receiving pension in unrevised pay scale (Sixth pay scale) from 136% (One Hundred and Thirty Six Percent) to 139% (One Hundred and Thirty Nine Percent) w.e.f. 01.07.2017.
- 5. Approval of this proposal has been given by the Council of Ministers in item no. 24 of the meeting of 07.11.2017 in continuation to Finance Department, Memorandum No. 3581/Fin. dated 07.11.2017.
