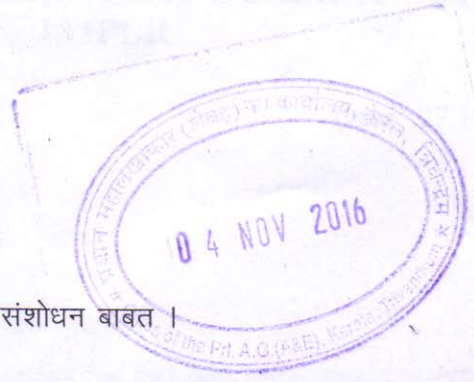

**NOTIFICATION**

In exercise of powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Pension) Rules, 1996, namely:—

**1. Short title and commencement.**- (1) These rules may be called the Rajasthan Civil Services (Pension) (Second Amendment) Rules, 2016.


(2) They shall come into force with immediate effect.

**2. Amendment of rule 66.**- In sub-rule (1) of rule 66 of the Rajasthan Civil Services (Pension) Rules, 1996, hereinafter referred to as the said rules,-

- (i) in clause (c), for the existing expression "Rs. 2550/-", the expression "Rs. 6,000/-" shall be substituted; and
- (ii) in clause (d), for the existing expression "Rs. 2550/-", the expression "Rs. 6,000/-" shall be substituted.

**3. Amendment of rule 143.**- In rule 143 of the said rules,-

- (i) in clause (b) of sub-rule (3), for the existing expression "Rs. 1,00,000/-", the expression "Rs. 3,00,000/-" shall be substituted;
- (ii) in sub-rule (4), for the existing expression "Rs. 1,00,000/-", the expression "Rs. 3,00,000/-" shall be substituted; and



- (iii) in sub-rule (4), for the existing expression "Rs. 5,00,000/-" wherever occurring, the expression "Rs. 7,50,000/-" shall be substituted.

**4. Amendment of rule 145.-** The existing sub-rule (1) of rule 145 of the said rules shall be substituted by the following, namely:-

"(1) The arrears of pension of a deceased pensioner shall be paid to the nominee of the pensioner if nomination in Form A or Form B, as the case may be, appended to the Payment of Arrear of Pension and Commutation (Nomination) Rules, 1996 is available. If nomination is not available, arrears of pension shall be paid to the recipient of the family pension of the deceased. In case, no family pensioner is authorized in the Pension Payment Order to receive family pension and dependents of pensioner is unable to produce the legal heirship certificate or legal authority, the payment of arrears of pension may be authorized by the Treasury Officer / Treasury Officer (Pension) on the basis of any documentary proof regarding the relationship and heirship of claimants, after such inquiry as he may deem fit, if gross amount does not exceed rupees 3,00,000/-. The amount of arrears exceeding rupees 3,00,000/- but upto rupees 7,50,000/- may be paid with the prior approval of the Joint Director, Pension and Pensioner Welfare Department, Regional Offices and amount of arrears exceeding rupees 7,50,000/- may be paid with the prior approval of the Director, Pension and Pensioner Welfare Department, Rajasthan. The amount of arrears exceeding rupees 3,00,000/- shall be paid on execution of an indemnity bond, with such sureties as may be ordered by the Joint Director, Pension and Pensioner Welfare Department, Regional Offices or the Director, Pension and Pensioner Welfare Department, Rajasthan, as the case may be. In any case of any doubt, payment shall be made only to the person producing legal authority."
