Sub: Grant of Dearness Relief to Central Government pensioners/Family pensioners and to the Retired Judicial Officers of the State of West Bengal- revised rate effective from 01/07/2015.

In continuation to this office circular No. Pen.Co-ordn/55 Vol.VI/142 Vol.III/65 Vol.IV/105 dated 07/05/2015 it is stated that Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Pension & Pensioners Welfare under their O.M. No F 42/10/2014-P&PW(G) dated 28/09/2015 have sanctioned Dearness Relief at the rate of **119%** with effect from **01/07/2015** in supersession of the rate mentioned in O.M. No F 42/10/2014-P&PW(G) dated 27/04/2015 to (i) All Civilian Central Government Pensioners/family pensioners (ii) The Armed Forces Pensioners, Civilian Pensioners paid out of the Defence Service Estimates, (iii) All India Service Pensioners / family pensioners (iv) Railway Pensioners and (v) The Burma Civilian Pensioners/family pensioners and pensioners' families of displaced Government pensioners from Pakistan, who are Indian national but receiving pension on behalf of Government of Pakistan and are in receipt of ad-hoc ex-gratia allowance of Rs.3500/- per month in terms of this Department's O.M. No. 23/1/97-P&PW(B) dated 23/02/1998 read with the Department's O.M. No 23/3/2008-P&PW(B) dated 15/09/2008.

Fraction of rupee of the amount to be paid as Dearness Relief shall be rounded off to the next rupee.

You are hereby authorized to make payment accordingly. Expenditure may be debited to 8793/ISS/WEST BENGAL.
