

For the revision of Pension/Family Pension, the Pensioner/Family Pensioner can apply online at the portal named "ARPANA" which is available in the internet with domain name www.pension.odishatreasury.gov.in. It can also be accessed through a link provided in the home page of IFMS, Odisha (www.odishatreasury.gov.in / www.ifmsodisha.gov.in). The mode of operation will be issued by Treasury Branch, Finance Department separately.

Pensioner/Family Pensioners can also submit application offline for revision of their basic pension/family pension by submitting the Annexure - 'C' along with copy of the front page of the PPO/FPPO directly in the Office of the Pension Disbursing Authority.
