The mode of operation will be issued by Treasury Branch, Finance Department separately.

Pensioner/Family Pensioners can also submit application offline for revision of their basic pension/family pension by submitting the Annexure – 'C' along with copy of the front page of the PPO/FPPO directly in the Office of the Pension Disbursing Authority.
