

विषय : दिनांक 01.01.2016 से पुनरीक्षित/प्रभावी राज्य सरकार के पेंशन/पारिवारिक पेंशनभोगियों को 01 जुलाई, 2017 के प्रभाव से महंगाई राहत की दरों में अभिवृद्धि के संबंध में।

केन्द्र सरकार के द्वारा अपने पेंशनधारियों/पारिवारिक पेंशनभोगियों को दिनांक 01.01.2016 के प्रभाव से सप्तम वेतन पुनरीक्षण के लाभ के अनुरूप राज्य सरकार के पेंशनधारियों/पारिवारिक पेंशनभोगियों को योजना-सह-वित्त विभागीय संकल्प संख्या 218/वि. दिनांक 18.01.2017 द्वारा सप्तम वेतन पुनरीक्षण अनुमान्य किया गया है। उक्त संकल्प की कंडिका- 9.1 में केन्द्र सरकार के अनुरूप महंगाई राहत अनुमान्य किया गया है।

2. भारत सरकार के कार्मिक, लोक शिकायत एवं पेंशन मंत्रालय, भारत सरकार के पत्र संख्या F.No. 42/15/2016-P&PW(G) दिनांक 28.09.2017 के द्वारा केन्द्रीय कर्मियों को पुनरीक्षित वेतनमान/वेतन सरचना (सातवें वेतनमान) में दिनांक 01.07.2017 के प्रभाव से महंगाई राहत की दर को 4% (चार प्रतिशत) की विद्यमान दर से बढ़ाकर 5% (पाँच प्रतिशत) के रूप में स्वीकृत किया गया है।

3. उपर्युक्त पृष्ठभूमि में केन्द्र के अनुरूप राज्य सरकार के पेंशनधारियों/पारिवारिक पेंशनभोगियों को वर्तमान पुनरीक्षित वेतनमान में दिनांक 01.07.2017 के प्रभाव से महंगाई राहत की दरों में संशोधन हेतु सम्यक विचारोपरांत राज्य सरकार ने निर्णय लिया है कि -

“राज्य के पेंशनधारियों/पारिवारिक पेंशनभोगियों, जिनके मूल पेंशन का पुनरीक्षण (सप्तम वेतन पुनरीक्षण) वित्त विभाग के संकल्प संख्या 218/वि. दिनांक 18.01.2017 द्वारा दिनांक 01.01.2016 के प्रभाव से किया गया है, उन्हें दिनांक 01.07.2017 के प्रभाव से मूल पेंशन का 5% (पाँच प्रतिशत) महंगाई राहत स्वीकृत किया जायेगा”।

4. प्रस्ताव पर मंत्रिपरिषद् की स्वीकृति वित्त विभागीय संलेख ज्ञापांक 3632/वि० दिनांक 09.11.2017 के क्रम में दिनांक 14.11.2017 की बैठक के मद सं० 01 में दी गई है।

RESOLUTION

Sub : Enhancement in the rates of dearness relief from 01.01.2016 to the state government pensioners/family pensioners revised/effective w.e.f. 01st July, 2017

In terms of the benefits of Seventh Pay revision by the Central Government to its pensioners/family pensioners w.e.f. 01.01.2016, seventh pay revision has been permitted to the State Government pensioners/family pensioners through Resolution No. 218/Fin. dated 18.01.2017 of Planning-Cum-Finance Department. In para - 9.1 of the above Resolution, dearness relief at par with Central Government has been permitted.

2. Vide letter no. F No. 42/15/2016/-P&PW(G) dated 28.09.2017 of Ministry of Personnel, Public Grievances & Pension, Government of India, sanction has been accorded for the enhancement of dearness relief to 5% (five percent) from the existing rate of 4% (four percent) w.e.f. 01.07.2017 to the central employees in the revised pay scale/pay structure (seventh pay scale).

3. In the above context, after due consideration for revision in the rates of dearness relief in the present revised pay scale to the State Government pensioners/family pensioners w.e.f. 01.07.2017 at par with Centre, the State Government have decided that-

“State pensioners/family pensioners, whose revision of basic pension (seventh pay revision) has been done through Resolution No. 218/Fin. dated 18.01.2017 of Department of Finance w.e.f. 01.01.2016, shall be sanctioned dearness relief of 5% (five percent) of basic pension w.e.f. 01.07.2017.”

4. Sanction of the Cabinet on this proposal has been given in item no.1 of the meeting dated 14.11.2017 in continuation to Finance Department, document memo no.3632/Fin. dated 09.11.2017.

Order : It is ordered that this Resolution be published in the extra ordinary edition of the Gazette of Jharkhand and its copies be forwarded to all the Treasuries/Sub Treasuries and the Accountant General (A&E), Jharkhand, Ranchi.
