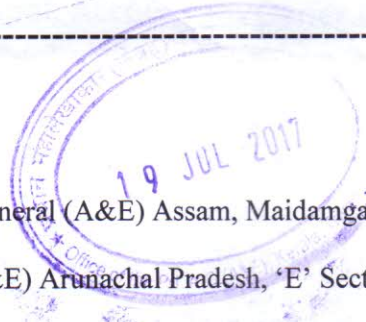



Subject: Increase of Dearness Relief to the Mizoram Government Pensioners/Family Pensioners.

The undersigned is directed to convey sanction of the Governor of Mizoram for enhancement of Dearness Relief by 7% to 126% with effect from 1.7.2016 (from the then rate of 119%) and further enhancement to 132% with effect from 1.10.2016 (from the existing rate of 125%)

2. The Enhanced Dearness Relief @ 7% shall be paid to all Pensioners/Family Pensioners of Government of Mizoram who continue to draw Pension/Family Pension.


3. Payment of Dearness Relief involving a fraction of Rupees shall be rounded off to the next higher rupee.

4. Payment of enhanced Dearness Relief should be made in Indian Rupee (INR).
