

1. सप्तम वेतन पुनरीक्षण के संदर्भ में योजना सह वित्त विभाग (वित्त प्रभाग) के संकल्प संख्या 737/वि० दिनांक 27.03.2018 के कंडिका 5(II) के द्वारा राज्य के सरकारी सेवकों को दिनांक 01.04.2018 के प्रभाव से नियत चिकित्सा भत्ता रुपये 1000/- (एक हजार) प्रतिमाह अनुमान्य किया गया है ।

2. राज्य के सरकारी सेवकों की भाँति पेंशन एवं पारिवारिक पेंशन भोगियों को नियत चिकित्सा भत्ता रुपये 300/- से बढ़ाकर रुपये 1000/- (एक हजार) प्रतिमाह अनुमान्य करने का प्रस्ताव राज्य सरकार के विचाराधीन था ।

3. सरकार द्वारा सम्यक विचारोपरान्त राज्य के पेंशन एवं पारिवारिक पेंशन भोगियों को भी दिनांक 01.06.2018 के प्रभाव से नियत चिकित्सा भत्ता 300/- (तीन सौ) से बढ़ाकर रुपये 1000/- (एक हजार) प्रतिमाह अनुमान्य करने का निर्णय लिया गया है ।

1. With reference to Seventh Pay Revision, vide para 5(II) of Resolution No. 737/Fin. dated 27.03.2018 of the Department of Planning Cum Finance (Finance Division), fixed medical allowance of Rs.1000/- (Rupees One Thousand only) p.m. has been sanctioned to State Government servants w.e.f. 01.04.2018.
