Sub:- Grant of Fixed Medical Allowance @ Rs. 1000/- p.m. to Goa Governmen Pensioners / family pensioners residing in areas not covered by C.G.H.S. with effect from 01/08/2017.

- 1. The Government of Goa, Finance (Rev. & Cont.) Department Secretariat, Porvorim, vide letter No. 8/6/99-Fin(R&C)FPC/Part File/2295 dated 05/09/2017 has conveyed the approval of the Government for adoption of revised Fixed Medical Allowances w,e.f 01/08/2017 to the Pensioners/Family Pensioners of Goa Government as contained in Government of India Office Memorandum No. 4/34/2017-P&PW/(D) dated 19th July 2017 issued by Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Pension, & Pensioners Welfare, New Delhi. The copy of the said Office Memorandum is enclosed for information and necessary action.
- Government of Goa is pleased to sanction the revised Fixed Medical Allowances
 of Rs. 1000/- p.m. to State Government Pensioners with effect from 01/08/2017.
- 3. The salient features of the Scheme are as follows:
 - a) The Fixed Medical Allowance is applicable to pensioners/family pensioners residing in areas not covered by C.G.H.S..
 - b) The Fixed Medical Allowance is for meeting Medical Expenses that do not require hospitalization.
 - c) Re-employed pensioners, employed family pensioners, recipients of ex-gratia payment, Freedom Fighter pensioners and M.L.A. Pensioners are not entitled to Fixed Medical Allowance.
 - d) Pensioners who are in receipts of two pensions are entitled to single Fixed Medical Allowance provided he/she does not avail of Medical Facilities for both pensions.
 - e) Where family pension is shared by two persons, same criteria as in the case of Dearness Relief shall be followed.
 - f) Payment shall be made alongwith pension /family pension.
 - g) Specific entry shall be made in both portions of Pension Payment Orders by the Pension Disbursing Authority regarding grant of Fixed Medical Allowance.

The undersigned is directed to say that at present Fixed Medical Allowance (FMA) is granted to the Central Government pensioners/family pensioners residing in areas not covered under Central Government Health Scheme administered by the Ministry of Health & Family Welfare and corresponding health schemes administered by other Ministries/Departments

for their retired employees for meeting expenditure on their day-to-day medical expenses that do not require hospitalization. Orders were issued vide this Department's O.M. No. 4/25/2008-P&PW(D) dated 19-11-2014 for enhancement of the amount of Fixed Medical Allowance from Rs. 300/- to Rs. 500/-per month w.e.f. 19.11.2014.

- 2. Consequent upon the decision taken by the Government on the recommendations of the 7th Central Pay Commission on Allowances (with modifications), sanction of the President is hereby conveyed for enhancement of the amount of Fixed Medical Allowance from Rs.500/- to Rs.1000/- per month. The other conditions for grant of Fixed Medical Allowance shall continue to be as contained in this Department's OMs No. 45/57/97-P&PW(C) dated 19.12.1997, 24.8.1998, 30.12.1998, 18.8.1999 and OM No. 4/25/2008-P&PW(D) dated 19.11.2014.
- 3. These orders will take effect from 01.07.2017.
- 4. In their application to the persons belonging to the Indian Audit and Accounts Department, these orders issue in consultation with the Comptroller and Auditor General of India vide their UO No. 169-Staff (Rules)/A.R/01-2016 dated 18.07.2017.
- 5. These orders are issued with the concurrence of the Ministry of Finance (Deptt. of Expenditure) vide their OM No. 11-1/2016-IC dated 11.07.2017.
