## CIRCULAR

Subject: Compilation of database of Pensioners of the Government of Nagaland.

- Reference is invited to this department's letter of even number dated 19<sup>th</sup> November 2018, wherein Pensioners/Family Pensioners of the Government of Nagaland had been asked to furnish details of retirement papers, PPO books, Aadhaar Card, Voter ID etc. In this connection, the Government has received various representations from the Pensioners who have expressed inability to produce the prescribed documents due to long passage of time.
- The matter has been examined. The Government has decided that in order to facilitate genuine Pensioners who are unable to furnish the prescribed documents earlier prescribed at para 2 clause (a), the Pensioner/Family Pensioner may submit a signed statement mentioning the name of the Pensioner, date of joining of Government service and date of retirement. The Pensioner/Family Pensioner may also furnish details of department and place of last posting, post held at the time of retirement/death, date of death of the Pensioner (If it is Family Pension), and name of the Family Pensioner (If Family Pension).
- The information so furnished may certified to be true to the best of knowledge and belief of the Pensioner/Family Pensioner, as the case may be.

I am directed to invite your kind attention to the above cited subject, and to state that the Government of Nagaland is presently in the process of building up a comprehensive database of its pensioners both within and outside the State. This exercise is experiencing difficulties due to non-availability of details of Pensioners living outside the State.

- 2. In this connection your good office is requested to kindly inform all Pensioners of the Government of Nagaland under your jurisdiction to furnish the following details:-
  - (a) Photocopies of documents relating to their retirement from service in Nagaland showing details of department, place of last posting and grade from which retired;
  - (b) Photocopy of the PPO book;
  - (c) Photocopy of Aadhaar Card/Voter ID Card;
  - (d) Information as to whether it is Live Pension/Family Pension.
- 3. As the process also involves verification of genuineness, Pensioners who fail to furnish the prescribed information are likely to face discontinuation of payments. It is also requested that the requisite information may be submitted to the Pension Cell of Finance Department, Government of Nagaland, New Capital Complex Area, Kohima 797004, or mailed to pensioncellnagaland@gmail.com.
