Subject:- Grant of Dearness Relief to the retired Judges of Supreme Court/High Courts and family pensioners of such Judges- revised rates effective from 01.01.2018.

Sir,

I am directed to refer to this department's letter of even number dated 9th February 2018 on the above subject and to say that consequent upon grant of further Dearness Relief (DR) on pension/family pension to the employees of Central Government and Central Autonomous Bodies vide Department of Pension & Pensioners Welfare's O.M. No. 42/06/2018-P&PW(G) dated 22nd March, 2018 (Copy enclosed), it has been decided that retired Judges of Supreme Court/High Courts and family pensioners of such Judges would be entitled to Dearness Relief on pension/family pension at the rate of 7% with effect from 1st January, 2018.

- Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- The provision governing grant of Dearness Relief to pensioners such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc., will remain unchanged.
- Other provisions contained in this Department's letter No. L-19016/3/97-Jus. dated 13th January, 1999 will remain unchanged.

- Accountant Generals/Pay and Accounts Officers are requested to arrange payment of dearness relief to the pensioners on the basis of the aforesaid instructions as per the procedure adopted by the Department of Pension & Pensioners' Welfare without any further delay.
- This issues with the concurrence of Integrated Finance Division vide their Dy. No.1702/AS&FA dated 05.04.2018.

OFFICE MEMORANDUM

Sub: Grant of Dearness Relief to Central Government pensioners/family pensioners - Revised rate effective from 01.01.2018.

The undersigned is directed to refer to this Department's OM No. 42/15/2016-P&PW(G) dated 28.09.2017 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government pensioners/family pensioners shall be enhanced from the existing rate of 5% to 7% w.e.f. 01.01.2018.

- 2. These rates of DR will be applicable to (i) Civilian Central Government Pensioners/Family Pensioners including Central Govt. absorbee pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D) Vol.II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years (ii) The Armed Forces Pensioners, Civilian Pensioners paid out of the Defence Service Estimates, (iii) All India Service Pensioners (iv) Railway Pensioners/family pensioners (v) Pensioners who are in receipt of provisional pension (vi) The Burma Civilian pensioners/family pensioners and pensioners/families of displaced Government Pensioners from Burma/ Pakistan, in respect of whom orders have been issued vide this Department's OM No. 23/3/2008-P&PW(B) dated 11.09.2017.
- 3. These orders shall not be applicable on CPF beneficiaries, their widows and eligible children who are in receipt of ex-gratia payment in terms of this Department's OM No.45/52/97-P&PW(E) dated 16.12.1997 and revised vide this Department's OM 1/10/2012-P&PW(E) dtd 27.06.2013.

Separate orders will be issued in respect of above category.

- 4. The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 5. The payment of arrears of Dearness Relief shall not be made before the date of disbursement of pension/family pension of March, 2018
- 6. Other provisions governing grant of DR in respect of employed family pensioners and re-employed Central Government Pensioners will be regulated in accordance with the provisions contained in this Department's OM No. 45/73/97-P&PW (G) dated 2.7.1999 as amended vide this Department's OM No. F.No. 38/88/2008-P&PW(G) dated 9th July, 2009. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.

- 7. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.
- 8. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.
- 9. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of relief to pensioners etc. on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528-TA, II/34-80-II dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GAND No. 2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.
- 10. In their application to the pensioners/family pensioners belonging to Indian Audit and Accounts Department, these orders issue after consultation with the C&AG.
- 11. This issues in accordance with Ministry of Finance, Department of Expenditure's OM No. 1/1/2018-E.II(B) dated 15th March, 2018.
