Vide No. FIN/Rop/Rel-8/87Vol-II dated 26/10/10 standing order of release of Dearness Relief to the Nagaland, State Government pensioners/Family pensioners as when sanctioned by the Government of India without any further order from the State Government or authorization from the Accountant General has been kept in abeyance till further notice (vide Finance Department, Government of Nagaland No. FIN/ROP/REL-8/87/(Vol.II) dated 26<sup>th</sup> February 2016). 
