- 2. From the Registrar (Admn.), High Court of Judicature at Hyderabad Roc.No. 666/2018-B1; dated 20-04-2018.

#### ORDER:

WHEREAS, the Government of India, in pursuance of directions of Hon'ble Supreme Court, had appointed the Second National Judicial Pay Commission to examine and make suitable recommendations relating to the pay structure and emoluments of Judicial Officers in the States and Union Territories, including pension and other post-retirement benefits and also to examine the work methods and work environment with a view to promoting efficiency in judicial administration;

- 2. AND WHEREAS, the said Judicial Pay Commission had submitted its interim report before the Hon'ble Supreme Court on  $9^{th}$  March, 2018;
- 3. AND WHEREAS, the Hon'ble Supreme Court of India in Writ Petition (Civil) No. 643 of 2015 vide its order dated 27<sup>th</sup> March 2018, has given directions to the State Governments for the implementing the interim relief (Pay) for Subordinate Judicial Officers as recommended by the Second National Judicial Pay Commission;
- 4. AND WHEREAS, in compliance with the directions of the Hon'ble Supreme Court of India and recommendations of High Court of Judicature at Hyderabad the Government has decided to implement the following interim relief (Pay) for Subordinate Judicial Officers as recommended by the Second National Judicial Pay Commission;
  - i) Interim relief to the extent of 30% of increase in Basic Pay with accrued increments shall be paid to all categories/ranks of Judicial Officers;
  - ii) The said increase in pay shall be treated as a separate component and no D.A., HRA or any other allowances are payable thereon.
  - iii) Arrears shall be worked out with effect from 01-01-2016 on the above basis.

- iv) On the same basis, the interim relief shall be provided to the pensioners and family pensioners with effect from 01-01-2016 and the arrears to be paid accordingly.
- v) The interim relief regarding the pay of the Judicial Officers as recommended by the Commission be implemented w.e.f. 1<sup>st</sup> of May, 2018 and the arrears payable pursuant to the above mentioned recommendations shall be paid on or before 30<sup>th</sup> June, 2018.
- vi) The amounts payable by way of interim relief now proposed are liable to be adjusted against the future determination pursuant to the final report submitted by the  $2^{nd}$  National Judicial Pay Commission.

This order issues with the concurrence of Finance (HRM.IV) Department vide their U.O. No.2408-B/99/A1/HRM.IV/2018, dated 29.05.2018.
