

Rs.1,000/- (Rupees One thousand) only per head.
2	DRWs / MRWs / PTW / Fixed Pay Employee and other similar workers engaged with prior concurrence of the Finance Department.	
3	DRWs / MRWs / Home Guard / PTW / Fixed Pay Employee and other similar workers engaged prior to 01-04-2004 without concurrence of the Finance Department.
