

Please refer to this office letter No.1/69/13-3Judl(1)/1754 dated 20.7.2018 and your letter No.37684/Pen-4 dated 1.11.2018 on the subject cited above.

2. In this connection, it is clarified that the pension of the Judicial Officers who retired between 01.01.1996 and 31.12.2005 and the retirees whose pensions were consolidated as per Karnataka Model shall be raised by 3.07 times of the pension, which they were drawing as on 31.12.2005, may be revised notionally w.e.f. 01.01.2006. The actual revised pension may be released from 01.07.2018.

3. Issue of arrears to be paid shall be decided in view of opinion of Advocate on record.
