## CIRCULAR

Subject: Discontinuation of pension payment function of the O/O the Accountant General (A&E), West Bengal.

It is informed that pursuant to the Government of West Bengal, Finance Department, Audit Branch Notification No 6431-F(Y) dated 15/12/2016, payment of pension/family pension to West Bengal Government pensioners including other Government pensioners, who are drawing their pension/family pension from the counter of the Office of the Accountant General (A&E), West Bengal will be transferred to the Pension Disbursement Office, located at Jahar Building, 5<sup>th</sup> Floor, P-1, Hyde Lane, Kolkata-70073 under the control of Directorate of Treasuries & Accounts, West Bengal or Treasuries in the districts of the State or specified Public Sector Banks (PSB) within the Kolkata Municipal Corporation area, depending upon the option to be exercised by the Pensioners/Family Pensioners. Besides, it has been decided by the State Government that no such pension/family pension will be disbursed from the counter of the office of the Accountant General (A&E), West Bengal from the month of March, 2017.

2. All Accountants General/Authorities concerned are, therefore, requested not to send any further special seal authority authorizing payment of pension from the pension payment counter of this office. However, authority may be issued for arranging payment of pension from Pension Disbursement Office located at Kolkata or other treasuries in West Bengal or Public Sector Banks in Kolkata subject to existence of reciprocal arrangement with the Government concerned in terms of the Govt. of India No.
