## OFFICE MEMORANDUM

Subject: Grant of additional Interim Relief @ 4% to Himachal Pradash Government Pensioner's w.e.f. 1-7-2018.

The undersigned is directed to invite a reference to the subject cited above and to say that the Governor, Himachal Pradesh is pleased to grant additional Interim Relief at the rate of 4% of basic Pension/ basic Family Pension to the Himachal Pradesh Government Pensioners/Family pensioners covered under CCS (Pension) Rules, 19/2 w.e.f. 1-7-2018.

- 2. These orders shall not apply to the Pensioners/Family Pensioners of All India Services Cadre of Himachal Pradesh.
- No Dearness Relief would be payable on this Interim Relief.
- 4. The amount of Interim Relief will be absorbed in the future pension/family pension revision.
- 5. This Interim Relief will be in addition to Interim Relief already granted @ 5% w.e.f. 1-8-2016, 4% w.e.f. 1-8-2017 and 8% w.e.f. 1-1-2016, vide this department O.M. No. Fin (Pen) B (10)-6/98-III, dated 2nd August, 2016,

- 4<sup>th</sup> August, 2017 and O.M. of even number dated 9<sup>th</sup> February, 2018 respectively.
- 6. Payment of Interim Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 7. It will be the responsibility of the Pension Disbursing Authorities, including the Nationalized Banks etc. to calculate the quantum of Interim Relief payable in each individual case.
- 8. The Accountant General, Treasury Officers and authorized Public Sector Banks are requested to arrange payment of interim relief on the basis of these orders immediately.
- 9. The Interim Relief on pension and family pension @ 4% will be paid with the pension/family pension for the month of August, 2018 payable in the month of September, 2018. The arrears accrued on account of grant of Interim Relief w.e.f. 1-7-2018 to 31-7-2018 (one month) shall be paid in cash in one instalment with the pension/family pension for the month of August, 2018 payable in the month of September, 2018.
