
Sir,

The State Government had sanctioned 9% dearness Relief w.e.f. 11-4-2019 on pension/family pension to their pensioners/family pensioners vide Finance Department Memo No. F 9-5/2017/Rule/IV dated 11 April, 2019.

2/ The State Government is pleased to sanctioned the Dearness Relief admissible to pensioners/family pensioners should be as given below.

The additional pension payable to the pensioner's aged 80 years or above shall also qualify for dearness relief.

3/ The above dearness relief shall be payable on the Superannuation, Retiring, Invalid and Compensation Pension. This dearness relief shall also be payable on the Compassionate Allowance sanctioned to the employees
