

संकल्प

विषय : राज्य सरकार के पेंशन/पारिवारिक पेंशनभोगियों को अपुनरीक्षित वेतनमान (छठा केन्द्रीय वेतनमान) में दिनांक 01.01.2018 के प्रभाव से महँगाई राहत की दरों में अभिवृद्धि के संबंध में।

वित्त विभाग के संकल्प संख्या 660/वि०, दिनांक 28.02.2009 के द्वारा राज्य सरकार के पेंशनधारियों/पारिवारिक पेंशनभोगियों को केन्द्र सरकार के पेंशनधारियों/पारिवारिक पेंशनभोगियों की भांति दिनांक 01.01.2006 के प्रभाव से अपुनरीक्षित (छठा वेतनमान) केन्द्रीय पेंशन/पारिवारिक पेंशन की स्वीकृति प्रदान की गई है। उक्त संकल्प की कंडिका-17 (ए०)(बी०) के अनुसार पेंशनधारियों/पारिवारिक पेंशनभोगियों को केन्द्रीय दर पर महँगाई राहत स्वीकृत किया गया है।

2. उपर्युक्त के अनुसार केन्द्र सरकार के पेंशनभोगियों के भांति दिनांक 01.01.2018 से राज्य सरकार के पेंशनधारियों/पारिवारिक पेंशनभोगियों को भी महँगाई राहत अनुमान्य किया जाता है। वर्तमान में राज्य सरकार के पेंशनधारियों/पारिवारिक पेंशनभोगी, जो अपुनरीक्षित वेतनमान (छठा वेतनमान) में पेंशन प्राप्त कर रहे हैं, को 139% (एक सौ उनचालीस प्रतिशत) महँगाई राहत अनुमान्य है।

3. केन्द्र सरकार के द्वारा अपने कर्मियों को दिनांक 01.01.2018 के प्रभाव से छठे वेतन पुनरीक्षण के लाभ के अनुरूप महँगाई भत्ते का पुनरीक्षण किया गया है और उसके आलोक में भारत सरकार के वित्त मंत्रालय (व्यय) के पत्र संख्या 1/3/2008 E.II(B) दिनांक 28.03.2018 के प्रभाव से छठे अपुनरीक्षित वेतनमान में महँगाई भत्ते की दर को 139% (एक सौ उनचालीस प्रतिशत) से बढ़ाकर 142% (एक सौ बयालीस प्रतिशत) स्वीकृत किया गया है।

4. केन्द्र सरकार के उक्त निर्णय को दृष्टिपथ में रखते हुए राज्य सरकार द्वारा सम्यक् विचारोपरान्त राज्य के पेंशनधारियों/पारिवारिक पेंशनभोगियों को, जो अपुनरीक्षित वेतनमान (छठा वेतनमान) में पेंशन प्राप्त कर रहे हैं, को दिनांक 01.01.2018 के प्रभाव से महँगाई राहत 139% (एक सौ उनचालीस प्रतिशत) से बढ़ाकर 142% (एक सौ बयालीस प्रतिशत) किये जाने का निर्णय लिया गया है।

5. प्रस्ताव पर मंत्रिपरिषद् की स्वीकृति वित्त विभागीय संलेख ज्ञापांक 1132/वि० दिनांक 15.05.2018 के क्रम में दिनांक 15.05.2018 की बैठक के मद सं० 06 में दी गई है।

आदेश : आदेश दिया जाता है कि इस संकल्प को झारखंड राजपत्र के असाधारण अंक में प्रकाशित किया जाये तथा इसकी प्रतियाँ सभी विभाग/सभी विभागाध्यक्षों एवं महालेखाकार (लेखा एवं हक*), झारखंड, राँची को प्रेषित किया जाय।

Resolution

Sub :- Enhancement in the rates of Dearness Relief to the pensioners / family pensioners of State Government in unrevised Pay Scale (Sixth Central Pay Scale) w.e.f. 01.01.2018 – reg.

Sanction has been accorded for unrevised (Sixth Pay Scale) central pension/family pension w.e.f. 01.01.2006 to the pensioners/family pensioners of State Government at par with the pensioners/family pensioners of Central Government, vide Resolution No.660/Fin. dated 28.02.2009 of Department of Finance. As per para 17(A) (B) of the above Resolution, Dearness Relief at central rate has been sanctioned to the pensioners/family pensioners.

2. In accordance with the above, Dearness Relief is sanctioned to State Government pensioners/family pensioners w.e.f. 01.01.2018 as in the case of Central Government pensioners. At present, 139% (One Hundred and Thirty Nine Percent) Dearness Relief is admissible to those State Government pensioners/family pensioners who are receiving pension in unrevised pay scale (Sixth Pay Scale).

3. Central Government has revised the Dearness Allowance to their officials w.e.f. 01.01.2018, in accordance with the benefits of Sixth Pay Revision. In light of the above, sanction has been accorded to increase the rate of Dearness Allowance from 139% (One Hundred and Thirty Nine Percent) to 142% (One Hundred and Forty Two Percent) in sixth unrevised pay scale w.e.f. letter no. 1/3/2008-E(II)(B) dated 28.03.2018 of Government of India, Ministry of Finance (Expenditure).

4. In view of the above decision of Central Government, the State Government after due consideration has decided to increase the DR to 142 % (One Hundred Forty Two percent) from 139% (One Hundred Thirty Nine percent) w.e.f 01.01.2018 to State Government pensioners/family pensioners receiving pension in unrevised pay scale (Sixth Pay Scale).

5. Sanction of the Council of Ministers on the proposal is given in item no.6 of the meeting of 15.05.2018 in continuation to Department of Finance, Memo No. 1132/Fin. dated 15.05.2018
