OFFICE MEMORANDUM

Sub:- Sanction of Dearness Relief (T.I) @ 3% enhancing the existing rate from 31% to 34% in favour of the State Government pensioners/ family pensioners with effect from 01.01.2022.

Government of India, Ministry of Personnel, Public Grievances & Pensions in their O.M.No.F-No.42/07/2022-P&PW(D) dated 05.04.2022 have enhanced the Dearness Relief admissible to the Central Government pensioners/family pensioners from the existing rate of 31% to 34% of the basic pension family pension (including additional pension/ family pension with effect from 01.01.2022.

- 2. In the meantime, one dose of Dearness Allowance @3% has been sanctioned in favour of the State Government employees enhancing Dearness Allowance from 31% to 34% with effect from 01,01.2022 vide Finance Department Office Memorandum No23377/F, dated 19.09.2022
- 3. After careful consideration of the matter, the State Government have been pleased to decide that Dearness Relief (T.I) on pension/ family pension shall be paid to the State Government pensioners/ family pensioners at the same rate of 3% on the revised basic pension/ family pension and provisional pension with effect from 01.01.2022. With sanction of one dose of Dearness Relief (T.I) at the rate of 3%, the Dearness Relief now payable on the revised basic pension/ family pension and provisional pension will be enhanced from 31% to 34% with effect from 01.01.2022.
- 4. The additional dose of Dearness Relief shall also be admissible on additional basic pension/additional family pension available to the old pensioners/ family pensioners based on their age as indicated in this Department O.M. NO.28300/F dated 23.09.2017.

For the purpose of this Office Memorandum

- i. Pension/family pension in the case of the pre-01.01.2016 retirees and where family pension was due prior to 01.01.2016 means the revised basic pension/revised basic family pension as the case may be in terms of Finance Department Office Memorandum No.28300/F dated 23.09.2017.
- ii. Also in the case of pensioners who have retired after 01.01.2016 or where family pension is sanctioned for the first time after 01.01.2016 the pension/ family pension means the basic pension / basic family pension, as the case may be sanctioned on retirement/death.
- 5. The additional dose of Dearness shall also be admissible to the pensioners/ family pensioners of Non-Government Aided Educational Institutions including Primary Schools under School and Mass Education Department and Non-Government Aided Educational Institutions under Higher Education Department.
- 6. Payment of Dearness Relief (T.I) involving fraction of a rupee shall be rounded off to the next higher rupee.

7. Other provisions governing grant of Dearness Relief (TI) to Pensioners such as regulation of Dearness Relief during employment/ re-employment and regulation of Dearness Relief where more than one pension is drawn will remain unchanged.

ORDER

(RULES DIVISION)

Sub: Grant of Dearness Relief to State Government Pensioners.

The Governor is pleased to order that the existing rate of Dearness Relief sanctioned vide Finance Department Order of even number dated 30-03-2022 to the State Government Pensioners who are in receipt of superannuation, retiring, invalid, compensation, family and extraordinary pension etc. shall be revised from 34% to 38% with effect from 01-07-2022.

For the purpose of this order -

- (i) Pension/Family Pension in the case of pre-01-01-2016 retirees and where Family Pension was sanctioned prior to 01-01-2016, means the Revised Pension or Revised Family Pension, as the case may be, effective from 01-01-2016 in terms of Finance Department Memorandum No. F.12(6)FD(Rules)/2017 dated 30-10-2017 as amended vide Order No. F.12(6)FD(Rules)/ 2017 dated 09-12-2017 and F.12(6)FD(Rules)/ 2017 Pt.-I dated 06-06-2018.
- (ii) In the case of pensioners who retire from service on or after 01-01-2017 or where family pension is sanctioned for the first time on or after 01-01-2017, Pension/Family Pension means the Basic Pension/Basic Family Pension, as the case may be, in terms of Finance Department Notification No. F.12(6)FD(Rules)/ 2017 dated 30-10-2017 as amended vide Order No. F.12(6)FD(Rules)/ 2017 dated 09-12-2017.
- (iii) Dearness Relief will also be admissible on the additional quantum of pension / family pension allowed to the pensioners who have attained the age of 80 years and above.
- (iv) Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- (v) Other provisions governing grant of dearness relief to pensioners' such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc., will remain unchanged.
- (vi) This order shall also be applicable in case of Pensioners/Family Pensioners who are in receipt of provisional pension.

- This order shall not be applicable in case of Old Age Pensions, (vii) Political Pensions or any other kind of similar pensions, which are not related to the service rendered under Government.
- Dearness Relief at revised rates as above would also be admissible (viii) to pensioners who retired/retire from service of Panchayat Samiti or Zila Parishad and whose Pension Payment Orders have been issued by the Director, Local Fund Audit Department or Director, Pension and Pensioners' Welfare Department, Rajasthan, Jaipur.
- Cash payment shall be admissible from 01-07-2022. (ix)

Grant of travel concession for visiting any place in India for the State Government Pensioners.

Sir.

I am directed to refer to the subject cited above and to say that the State Government has introduced a new scheme of leave travel concession for visiting Home Town and any place in India for the State Government employees vide letter dated 5,2.2009 and 18.5.2009. According to this policy, one month's salary would be admissible to the State Government employees in a block of four years in lieu of LTC/HTC facility. The facility of travel concession, however, was not available to the State Government Pensioners.

- The matter has been considered and it has now been decided by the 2. Government that a similar facility for the State Government pensioners may also be. introduced. 3.
- Accordingly, the following scheme of travel concession to the State Government pensioners is hereby put in place :-
 - (i) He/she shall be entitled to draw the 'one month's pension' as himp surn assistance once in the block of four years as declared by the Government of Haryana as the block regulating the LTC;

The current block as declared by the Government of Haryana happens to be 2008-2011 (1.1.2008 to 31.12.2011) and the subsequent blocks shall be 2012-2015; 2016-2019; 2020-2023; and

Provided that the pensioner, who has retired during the current block of four years (2008-2011) and has availed the benefit of LTC before their retirement in this block under the scheme of leave travel concession available to the Sinta Player

(iii) Pension means the entitlement of basic pension inclusive of commuted pension and the dearness allowance admissible thereon being drawn under the Punjab Civil Services Rules. Vol. II as amended from time to time and as applicable to the pensioners of Haryana Government.

AND STATE OF STATE OF

- (iv) LTC being a family allowance, when both the spouses are pensioners or one of the spouse is working in organisation offering the facility of LTC, only one of the spouses shall be entitled to draw the benefit of LTC. Accordingly before the claim to draw the 'entitled amount' interms of this instruction is made, the concerned pensioner, claiming the benefit under the scheme, shall submit an undertaking that his/her entitled family members, including the spouse, when is the pensioner or in service of Government of Haryana, shall not avail the benefit promised by the scheme separately or when in employment under the Central Government or any other State Government or under any other organisation/institution/body, etc, wholly or substantially owned or controlled by the Central Government or any State Government shall not avail of the facilities of LTC from their employer in whatever form it is extended to him/her by their respective employer. Such an undertaking must be countersigned by the spouse of the concerned pensioner. Alternatively, the concerned pensioner shall submit an undertaking that the provisions of this para is not nitracted in his/her case as none of his/her entitled family members, including the spouse. is either pensioner of In service of Government of Haryana or in service under the Central Covernment oc any other State Covernment or under any other organisation/institution/body, etc. wholly or substantially owned or controlled by the Central Government or any State Government.
- (v) For the purposes of this instruction, 'Family' would mean a lawfully acknowledged family and any voluntary or even otherwise acknowledged separation, etc. would not charge the intent till such time as the marriage finally dissolves interms of law.
- (vi) The authority competent to anthorise disbursal of pension to the concerned pensioner shall also be competent to disburse the entitled amount in his/her case.
- (vii) The pension to the pensioners of age group of 90 years and above shall be disbursed along with the regular pension for the morali of January in the first year of the block of four years; the pension to the

disbursed alongwith the regular pension for the month of January in the second year of the block of four years, the pension to the pensioners of age group of 70 years and below 80 years shall be disbursed alongwith the regular pension for the month of January in the third year of the block of four years and the pension to the pensioners of age group of below 70 years shall be disbursed alongwith the regular pension for the month of January in the fourth year of the block of four years.

- (viii) During the current block of four years 2008-2011 (1.1.2008 to 31.12.2011), the pension to the pensioners of age group of 80 years and above shall be disbursed in the current year ending on 31.12.2009. For the pensioners above 70 years and below 80 years, they would be disbursed the travel allowance alongwith the pension for the month of January, 2010 and for the pensioners below 70 years, the travel allowance would be paid alongwith their pension for the month of January, 2011.
- (ix). This being an allowance, no arrears would be admissible even when the pension is revised from a retrospective date.
- 4. If any question/doubt arises as to the interpretation of these instructions, it shall be referred to the office of Chief Secretary, Haryana for decision/clarification.
- 5. These instructions should be brought to the notice of all concerned for strict.

Sub: Grant of Dearness Relief to Central Government pensioners/family pensioners - Revised rate effective from 01.07.2022.

The undersigned is directed to refer to this Department's OM No. 42/07/2022-P&PW(D) dated 05.04.2022 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government pensioners/family pensioners shall be enhanced from the existing rate of 34% to 38% w.e.f 01.07.2022.

- 2. These rates of DR will be applicable to the following categories:
 - i. Civilian Central Government Pensioners/Family Pensioners including Central Govt. absorbee pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D)Vol.II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years.
- ii. The Armed Forces Pensioners, Civilian Pensioners paid out of the Defence Service Estimates.
- iii. All India Service Pensioners
- iv. Railway Peńsioners/family pensioners
- v. Pensioners who are in receipt of provisional pension
- vi. The Burma Civilian pensioners/family pensioners and pensioners/families of displaced Government Pensioners from Burma/ Pakistan, in respect of whom orders have been issued vide this Department's OM No. 23/3/2008-P&PW(B) dated 11.09.2017.
- 3. The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- Other provisions governing grant of DR in respect of employed family pensioners and reemployed Central Government Pensioners will be regulated in accordance with the provisions contained in Rule 52 of CCS (Pension) Rules, 2021 and this Department's OM No. 45/73/97-P&PW (G) dated 2.7.1999 as amended from time to time. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.
- 5. In the case of refred Judges of the Supreme Court and High Courts, necessary orders will-

- It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.
- The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of relief to pensioners etc. on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528-TA, II/34-80-II dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.
- In so far as the persons serving in Indian Audit and Accounts Department are concerned, these orders are issued in consultation with the Comptroller and Auditor General of India, as mandated under Article 148(5) of the Constitution of India.
- This issues in accordance with the Ministry of Finance, Department of Expenditure's OM No. 1/3/2022-E.II(B) dated 03.10.2022.
