**Grant of Dearness Relief to the Retired Judicial Officers / family pensioners of the State of West Bengal - revised rate effective from 01/07/2016**

Sir,

The Government of West Bengal, Judicial Department has communicated under No. 925-J/JD/V/2A-04/17 dated 03/03/2017 that the rate of dearness relief on basic pension/family pension for the retired Judicial Officers of Govt. of West Bengal and family pensioners of such category whose pension / family pension have been regulated / revised in terms of Judicial Department Memo No. 7012-J and 7014-J, both dated 25/10/2010, has been enhanced from 125% to 132% with effect from 01/07/2016.

Accordingly, in continuation to this office circular No. Pen. Co-ordn./55 Vol.VI/142 Vol.III/65 Vol.IV/13 dated 25/04/2016 and No. Pen.Co-ordn./55 Vol.VI/142 Vol.III/65 Vol.IV/66 Vol.III/158 dated 01/12/2016, all concerned Pension Disbursing Authorities are requested to make necessary arrangement for payment of Dearness Relief @ **132%** to the above category of pensioners / family pensioners with effect from 01/07/2016 after proper adjustments of payment already made.

Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

Charges for payment are debitable to the Govt. of West Bengal, under head 2071 – Pension and other Retirement Benefits – 01 – Civil – 101 Superannuation and Retirement allowances etc.
