The Additional Chief Secretary to Government of Haryana Finance Department Chandigarh vide letter No. 2/9/2017-1 Pension dated 11-10-2018 has amended the Haryana Civil Services (Judicial Branch) and Haryana Superior Judicial Services (Revised Pension) Part-I Rules, 2011 (circulated to you vide Pen-1/revision /Judicial/2011-12/287-370 dated 11/05/2018), in clause (iv) of sub rule (1) of rule 5,-

- (i) In the existing proviso for the sign “,”. The sign “.” Shall be substituted: and
(ii) After the existing proviso, the following proviso shall be inserted namely:-
“Provided that the Judicial Officers who retired between 1st January, 1996 and 31st December, 2005, their pension shall now be revised by raising the same by 03.07 times with effect from the 1st January 2006.
