NOTIFICATION

Subject: Modification to the existing provision under para 2 of Tripura Civil Services (Revision of Pension of Judicial Officers) Rules, 2010.

In supersession of earlier Notification of even number dated 24-12-2010, 21-08-2013 and 27-09-2017 regarding revision of pension of the Tripura Judicial Service Officers who had retired/ ceased to be in service due to death or otherwise prior to 01-01-2006 and in pursuance of the directions of the Hon'ble Supreme Court in I.A. No. 244 in WP(C) No. 10/ 1989 in the All India Judges Association & Ors. Vs Union of India and Ors. for implementation of justice E. Padmanabhan committee recommendations for sub- ordinate judiciaries dated 04-05-2010 and in compliance to Hon'ble Supreme Court of India judgment and order dated 14.07.2016 in I.A. No. 244/2009 in W.P.(Civil) Nos. 1022/1989 and in obedience thereof, the pension of retired judicial officers of Tripura Judicial Service who have retired/ ceased to be in service due to death or otherwise between 01-01- 1996 and prior to 01-01-2006 shall be revised as under:-

"The pension of the Tripura Judicial Officers who retired/ ceased to be in service due to death or otherwise between 01-01-1996 and prior to 01-01-2006 shall be revised by raising the existing pension by 03.07 times w.e.f. 01-01-2006, subject to minimum of 50% of the pay in the revised scale of pay of the post held by him/ her at the time of retirement, shown in the table below:


Provided that at the time of revision and re-fixation, the existing pension shall be consolidated first as follows:

- (i) Existing Pension as on 31-12-2005,
- (ii) Dearness Pension as on 31-12-2005,
- (iii) Dearness Relief @ 24% on both the existing Basic Pension and Dearness Pension as on 01-01-2006, and

Provided further that

- (i) There should not be ceiling limit on the maximum pension benefit ;
- (ii) The dearness relief shall be at the rates as are applicable to the serving Judicial Officers ;
- (iii) The family pension shall be revised and re-fixed at 30% of the revised pay of the post held by the pensioner at the time of retirement in the revised pay Scale given in the above Table ;
- (iv) ACP Scales referred to in the table above and applicable for the pensioners who retired while drawing ACP Scales of post, held by the pensioners at the retirement.

2) All the Scheduled Commercial Banks, Public Sector Banks handling disbursement of pension/ family pension of the State Government pensioners and family pensioners shall revise and re-fix the pensions and family pensions sanctioned as above and after making necessary entries in the Pension Payment Orders make payments to the retired Judicial Officers and family pensioners without waiting for further authorization/ instructions from the Accountant General (A& E), Tripura. The arrears of revised pension together with dearness relief and other allowances to be calculated with effect from 01-01-2006, shall be credited in the bank account of the pensioners. In the event of death of pensioners or family pensioners, the arrears of revised pension and family pensions together with dearness relief shall be paid to the legal heirs.
