

विषय:- पुनरीक्षित वेतन संरचना में वेतन प्राप्त कर रहे राज्य सरकार के सरकारी सेवकों को दिनांक 01/07/2018 के प्रभाव से 7 प्रतिशत के स्थान पर 9 प्रतिशत महंगाई भत्ता की स्वीकृति के संबंध में।

वित्त विभाग के संकल्प सं०-3249, दिनांक-04/05/2018 द्वारा पुनरीक्षित वेतन संरचना में वेतन प्राप्त कर रहे राज्य सरकार के कर्मचारियों को दिनांक 01/01/2018 के प्रभाव से 7 प्रतिशत की दर से महंगाई भत्ता की स्वीकृति प्रदान की गई है।

2. भारत सरकार वित्त मंत्रालय के कार्यालय ज्ञाप सं०- 1/2/2018-E-II(B) दिनांक-07/09/2018 के द्वारा पुनरीक्षित वेतन संरचना में वेतन आहरित करनेवाले केन्द्रीय कर्मियों को दिनांक 01/07/2018 के प्रभाव से महंगाई भत्ता की दर 7 प्रतिशत से बढ़ाकर 9 प्रतिशत स्वीकृत किया गया है।

3. राज्य सरकार भी अपने कर्मियों को महंगाई भत्ता की स्वीकृति केन्द्र सरकार के अनुरूप उसी दर पर एवं उसी तिथि से करती रही है।

4. उक्त के आलोक में राज्य सरकार ने सम्यक विचारोपरान्त निर्णय लिया है कि-

(i) पुनरीक्षित वेतन संरचना में वेतन प्राप्त कर रहे राज्य कर्मियों को दिनांक-01/07/2018 के प्रभाव से 7 प्रतिशत के स्थान पर 9 प्रतिशत महंगाई भत्ता की स्वीकृति प्रदान किया जाता है।

(ii) पुनरीक्षित वेतन संरचना में 'मूल वेतन' का तात्पर्य पे-मैट्रिक्स में विहित वेतन स्तर में आहरित किए जाने वाले वेतन से है। इसमें विशेष वेतन अथवा वैयक्तिक वेतन को शामिल नहीं किया जाएगा।

(iii) महंगाई भत्ता की गणना में 50 पैसे या उससे अधिक पैसे अगले रूपये में पूर्णकृत कर दिया जायगा तथा 50 पैसे से कम राशि को छोड़ दिया जायेगा।

- (v) उपर्युक्त महंगाई भत्ता की राशि का नगद भुगतान किया जाएगा। कोषागार पदाधिकारी द्वारा महालेखाकार/वित्त वैयक्तिक दावा निर्धारण कोषांग के प्राधिकार पत्र की प्रतीक्षा किये बिना देय भुगतान तत्काल औपबन्धिक रूप से कर दिया जाएगा।

5. उक्त बढ़ी हुई दर से महंगाई भत्ता दिनांक-01/07/2018 से भुगतेय है और इसका भुगतान अक्टूबर, 2018 के वेतन में जोड़कर होगा, परन्तु इसके पूर्व के महीनों के लिए आकलित बकाये राशि का भुगतान माह नवम्बर, 2018 में किया जाएगा।

6. उच्च न्यायालय/बिहार विधान सभा/बिहार विधान परिषद् के कर्मियों को पुनरीक्षित वेतनमान में उक्त महंगाई भत्ता का भुगतान मुख्य न्यायाधीश, पटना उच्च न्यायालय/अध्यक्ष, बिहार विधान सभा/सभापति, बिहार विधान परिषद् की स्वीकृति से देय होगी।

आदेश- आदेश दिया जाता है कि इस संकल्प को बिहार राजपत्र के अगले अंक में सर्वसाधारण की जानकारी हेतु प्रकाशित किया जाय।



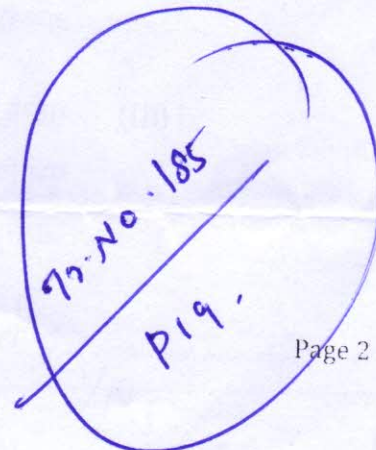

RESOLUTION

Patna, Dated 24.10.2018

Sub :- Sanction of 9 % Dearness Allowance in the place of 7 % w.e.f. 01.07.2018 to State Government employees receiving pay in the revised pay structure

Vide Department of Finance, Resolution No. 3249 dated 04.05.2018, sanction has been accorded for dearness allowance at the rate of 7% w.e.f. 01.01.2018 to State Government employees receiving pay in the revised pay structure.

2. Vide Government of India, Department of Finance, OM No. 1/2/2018-E-II(B) dated 07/09/2018, sanction has been accorded to enhance the rate of dearness allowance to Central Government employees drawing pay in the revised pay structure, from 7% to 9% w.e.f. 01.07.2018.

3. The State Government also accord sanction of dearness allowance to their employees at the same rate and from the same date in accordance with Central Government.

4. In light of the above, the following decisions have been taken by the State Government after due consideration -

- (i) Sanction is accorded for 9% dearness allowance in the place of 7% w.e.f. 01.07.2018 to the State Government employees receiving pay in the revised pay structure.
- (ii) 'Basic pay' in revised pay structure means the pay drawn in the prescribed Pay Level in the Pay Matrix. Special Pay or Personal Pay shall not be included therein.
- (iii) In the calculation of dearness allowance, 50 paise or more shall be rounded off to next higher rupee and the amount less than 50 paise shall be ignored.
- (iv) Payment of the amount of above dearness allowance shall be made in cash. Payment shall be made provisionally by the Treasury Officer immediately without waiting for the authority letter of the Accountant General/Finance Personal Claims Determination Cell.

5. Dearness allowance at the above increased rate is payable from 01.07.2018 and its payment shall be made by adding in the pay for the month of October, 2018, but payment of the arrear amount calculated for earlier months shall be made in the month of November, 2018.

6. Payment of above dearness allowance to the employees of High Court/Bihar Legislative Assembly/Bihar Legislative Council shall be made with the sanction of the Chief Justice, Patna High Court/Chairman, Bihar Legislative Assembly/Speaker, Bihar Legislative Council.

ORDER - It is ordered that this Resolution be published in the next edition of the Gazette of Bihar, for the information of general public.
