## Subject: Interim Relief to the Retired Judicial Officers Haryana

With reference to the Finance Department, Govt. of Haryana U.O. No. 2/14/2018-1Pension (FD) dated 02.01.2019, The Chief Secretary to Government of Haryana (Service III Branch) Chandigarh vide letter No. 28/35/2016-5SIII dated 4<sup>th</sup> January 2019 has intimated that in compliance of the order dated 27.03.2018 of Hon'ble Supreme Court of India, New Delhi passed in WP( C ) No. 643 of 2015 along with report dated 09.03.2018 of Second National Judicial Pay Commission State Govt. accords sanction as under:

- (i) To grant interim relief @ 30% (Thirty Percent) of the basic pension/family pension drawn as on 31.12.2015 to the pre-2016 retired Judicial officer viz. Civil Judge (Jr. Division), Civil Judge (Sr. Division) and District Judges.
- (ii) The amount of interim relied as liable to be adjusted in the future determination/ revision of pension/family pension pursuant to the final report submitted by the commission.
- (iii) The amount of interim relief shall be treated as a separate component and no dearness relief (DR) is payable thereon.
- (iv) The above benefit is admissible w.e.f. 01.01.2016.
