I am to enclose herewith the copy of SSA received from the Directorate of Accounts, Government of Goa regarding the grant of Dearness Relief to Goa State Pensioners/Family Pensioners of state Government and its Autonomous bodies, who continue to draw their Pay and Allowances in pre- revised scale as per 6<sup>th</sup> Central pay Commission and drawing DR at rate 125%. The DR rate has been enhanced from time to time are as follows-

125% w.e.f. 01.01.2016

132% w.e.f. 01.07.2016

139% w.e.f. 01.07.2019

142% w.e.f. 01.01.2018

And present enhanced DR rate 148% w.e.f. 01.07.2018

DR rates are payable either from effective date of enhancement of DR or date of commencement of pension whichever is later except exceptions as mentioned in order. 


**Sub: - Grant of Dearness Relief to State Government Pensioners/ Family Pensioners - Revised rate effective from 01/07/2018.**

1. The Government of Goa, Finance (Rev. & Cont.) Department Secretariat, Porvorim, vide letter No. 12/1/2019-Fin(R&C) dated 11/02/2019 have conveyed the sanction for revision of Dearness Relief to the Pensioners/Family Pensioners of employees of Goa Government and its Autonomous Bodies **who are in receipt of pension in pre-revised pay structure/scales of 6<sup>th</sup> Central Pay Commission**. The copy of the said Office Memorandum is enclosed for information and necessary action.
2. Since the order on relief contained in the above Finance (Expenditure) Department Memorandum **are applicable to the employees/ Pensioners and Family Pensioners of State Government and its Autonomous bodies who continue to draw their pay and allowances in the pre-revised scale of pay as per 6<sup>th</sup> Central Pay Commission and drawing DR at rate of 125%. I am to authorize you to pay employees/Pensioners/Family Pensioners of State Government and its autonomous bodies, the revised rates of Dearness Allowances which has been enhanced from time to time i.e. 125% w.e.f.01/01/2016, 132% w.e.f.01/07/2016, 136% w.e.f.01/01/2017, 139% w.e.f.01/07/2017, 142% w.ef.01/01/2018 and 148% w.ef.01/07/2018, the instalment of 6% of Dearness Relief raising it to 148% with effect from 01/07/2018 or date of commencement of pension whichever is later. Further, the said Office Memorandum No. 12/1/2019-Fin(R&C) dated 11/02/2019 is also applicable to the following pensioners and should be paid relief accordingly.**
3. In case of Goa State Government Pensioners drawing pension in other States, the instructions contained in above Office Memorandum may be issued to all the Treasuries/Sub-Treasuries/P.A.O where they are drawing their monthly pension.
4. This relief is not applicable to the following class of pensioners
  - a. Pensioners drawing pension, which is granted after Independence for Political consideration(Ex-Rulers).
  - b. Retired High Court and Supreme Court Judges for whom order will be issued separately by administrative authorities concerned.
  - c. Pensioners of other states (PAO) Suspense) for whom separate orders are applicable.

5. Instructions issued from time to time by this office as regards to payment of relief should be observed.
  6. Wide Publicity may be given to this circular letter by displaying a copy on the office notice board or other permanent place in your office.
  7. Pensioners who have drawn part payment of their pension through Treasury Office after 01/07/2018 and have subsequently opted for payment of their pension through Bank may also be paid arrears from the date of their retirement or from 01/07/2018 whichever is earlier without waiting for any individual orders from this office.
