Subject : Grant of Interim Relief to all West Bengal Govt. pensioners/  
family pensioners with effect from 01-07-2016.

It is informed that Govt. of W.B., Finance Department, Pension Branch in their Memo no. 224-F (Pen) dated 03/06/2016 have sanctioned **interim relief @ 8%** on basic pension/ family pension with effect from **01/07/2016** to all existing West Bengal Govt. pensioners/family pensioners including the pensioner/family pensioners guided by University Pension Rules, the pensioner/family pensioners belonging to non-teaching staff of Non-Govt. Colleges, and teaching and non-teaching employee of Non-Government Sponsored/Aided Educational Institutions under the Govt. of West Bengal.

2. The above rate of Interim Relief is **not** admissible to the following categories of pensioner/family pensioners:-

- a) Pensioners guided by All India Service Rules;
- b) Pensioners/family pensioners belonging to West Bengal Judicial Service;
- c) Pensioners retired from D.A. Getting Institution;
- d) Pensioners/family pensioners of Govt. & Non Govt. Colleges covered under UGC/AICTE scales of pay (i.e. retired teaching staffs including Librarian, Laboratory Instructors, Physical Instructors, Demonstrators of Govt. & Non-Govt. General Degree Colleges, Engineering Colleges & Polytechnic Colleges;
- e) Political pensioners;
- f) War Risk pensioners;
- g) Special pensioners;
- h) Pensioners who migrated from Pakistan; &
- i) Pensioners guided by Bihar Pension Rules


The Interim Relief is payable to the pensioners/family pensioners concerned, subject to the following conditions:-

(a) The Interim Relief shall remain as **separate fixed element** and **no Dearness Relief** is admissible on the Interim Relief;

(b) where a pensioners/family pensioner is in **receipt of more than one** pension/family pension from the Govt. of West Bengal, Interim Relief shall be admissible on **any one** of the pensions/family pension;

4. The Interim Relief shall also be admissible to the re-employed/contractually employed pensioner drawing consolidated pay and dearness relief on pension but not to the employed family pensioners.

5. All Pension Disbursing Officers concerned are, therefore, requested to make necessary arrangements for payment of Interim relief at the rates and from the date as mentioned above to all the above eligible existing pensioners/family pensioners of the Govt. of West Bengal. Future pensioners/family pensioners of such categories may also be paid Interim Relief at the above rate from the date of commencement of their pension/family pension or with effect from 1/7/2016, whichever is later, until further instructions from this end.
