

OFFICE MEMORANDUM

Sub:- Revision of pension of pre-2006 pensioners - Reg.

The undersigned is directed to say that in pursuance of Government's decision on the recommendations of Sixth Central Pay Commission, orders were issued for revision of pension/family pension vide this Department's OM No.38/37/08-P&PW(A) dated 1.9.2008, as amended from time to time.

2. The pension/family pension of pre-2006 pensioners was stepped up to 50% of the sum of minimum of pay in the pay band and the grade pay corresponding to the pre-revised pay scale from which the pensioner had retired as arrived at with reference to the fitment tables annexed to the Ministry of Finance, Department of Expenditure OM No.1/1/2008-IC dated 30th August, 2008 with effect from 24.9.12 vide this Department OM of even number dated 28th January, 2013.

3. In regard to disbursement of revised pension/family pension, while Head of Departments are responsible for sanctioning of pension/family pension, in cases where revision has already been done by PAOs consequent to 6th CPC, the revision may be effected at the level of PAOs. A copy of the revised authority may be sent to HOD/DDO for record. In cases where no revision has been effected, Head of Offices may follow normal procedure for revision of pension/family pension. Even in cases where there is no change in pension/family pension as a result of the issue of this OM, a revised authority for no change may be issued by the PAOs. The finalized authority will be sent to CPAO for further necessary action.

4. A suitable entry regarding the revised pension/family pension shall be recorded by the pension Disbursing Authority in both halves of the Pension Payment Order.

5. In case the pension/family pension in respect of pre-2006 pensioners/family pensioners has not already been revised w.e.f. 1.1.2006, the same may also be revised for the period upto 23.9.2012 in terms of order dated 1.9.2008 and subsequent orders thereto and for the period from 24.9.12 in terms of order of even number dated 28.1.2013.

6. CGA/CPAO/Ministry of Defence/Ministry of Railways/Department of Posts/Department of Telecom will devise their own monitoring mechanism to ensure that enhanced pension and arrears are disbursed to all civil pensioners/family pensioners expeditiously.

Sir,

As directed, it is stated on the above mentioned subject that as per the provision in Resolution No. 660 dated 28.02.2009 of Finance Department, Jharkhand, Ranchi, revision of pension of pre - 01.01.2006 state government pensioners receiving pension from bank/treasury, has to be done by the concerned bank/treasury itself.

The above resolution has been amended in the case of revision of pension of pre - 01.01.2006 state government pensioners as that of Central Government and Resolution No. 858/Fin. dated 27.03.2015 (enclosed) has been revised. As these resolutions are not followed strictly, the office of the Accountant General, Jharkhand, Ranchi and the pensioners are facing problems and as a result a number of petitions have been filed by the pensioners in the Honourable High Court of Jharkhand, Ranchi.

Therefore, viewing the matter seriously, all subordinate banks are directed to ensure revision of pension of pre - 01.01.2006 state government pensioners in the light of the above Resolution.

RESOLUTION

Sub :- Revision in the provisions of Chapter -5 as described in para 17 of Resolution No. 660/Fin dated 28.02.2009 of Finance Department regarding revision of pension/family pension of pre 01.01.2006 State Government pensioners.

Provisions were made in Chapter -5 as described in para 17 of Finance Department, Resolution No. 660/Fin dated 28.02.2009 for the revision of pension of State Government pensioners/family pensioners w.e.f. 01.01.2006 and earlier.

2. The provisions in the above Resolution regarding grant of pension and family pension as per the provisions described in schedule I and II vide letter nos. 38/37/08 P&PW(A) dated 01.09.2008 and 03.10.2008 of Ministry of Personnel, Public Grievances & Pension (Pension and Pensioners Department), Government of India has been accepted by the state government.

3. Again, the pension of central pensioners and family pensioners has been revised by the Government Of India vide schedules (no. 1 to 36) of letter no. 37/38/08 P&PW(A) dated 13.02.2013 and letter no. 37/38/08 P&PW(A) dated 28.01.2013 annexed to it..

4. As a result of the above amendment issued through the letter of Government Of India, the proposal for making corresponding amendment in Annexure I to Chapter -5 of Finance Department, Jharkhand Resolution No. 666/Fin. dated 28.02.2009, was under consideration of the state government.

5. Therefore, after due consideration, decision has been taken for the payment of revised pension to the pensioners/family pensioners as per the pay scales mentioned in the provisions/schedule described in letter nos 38/37/08 P&PW(A) dated 13.02.2013 and letter no. 38/37/08 P&PW(A) dated 28.01.2013 (enclosed) of Central Pension and Pensioners' Welfare Department .

6. Payment of arrear amount on account of the difference consequent to revision/enhancement in pension/family pension will be made w.e.f. 24.09.2012. Payment of outstanding pension for the period from 01.01.2006 to 23.09.2012 will be made in accordance with the earlier provision.

7. The above provision shall be treated as incorporated to this extent in Chapter-5 as described in para-17 of Finance Department Resolution No.660/Fin Dated 28.02.2009.

8. Sanction has been accorded to the proposal by the Council of Ministers in item no.24 of the meeting dated 17.03.2015.

Order :- It is ordered that this Resolution be published in the Extra Ordinary Edition of the Gazette of Bihar and its copies forwarded to the Accountant General (Accounts and Entitlement), Jharkhand, Ranchi/All Departments and Heads Of Departments.

SUB :- Revision of Pension of Pre-2006 Pensioners – reg.

The undersigned is directed to say that in pursuance of the decision of Government on the recommendations of Sixth Central Pay Commission, orders were issued for the revision of pension of pensioners/family pensioners vide Government's OM No. 38/37/2008-P&PW (A) dated 01.09.2008 as amended from time to time.

2. It has been decided that the pension of pre-2006 pensioners, which were revised w.e.f.01.01.2006 under the conditions of para 4.1 and 4.2 of above OM dated 01.09.2008 as revised from time to time, shall be stepped up to 50% of the sum of minimum of pay in pay band and grade pay corresponding to the pre revised scale of pay from which the pensioner had retired as arrived at with reference to the fitment tables annexed to Ministry of Finance, Department of Expenditure OM No. 1/1/2008-IC dated 30th August, 2008. In the case of HAG and higher pay scales, it shall be 50% of the minimum of pay in revised pay scales as arrived at with reference to the fitment tables annexed to the above OM dated 30.08.2008 of Ministry of Finance, Department of Expenditure.

3. Under the conditions of para 4.1 and 4.2 of above OM dated 01.09.2008 as revised from time to time, the ordinary family pension in respect of pre 2006 pensioners/family pensioners shall also be revised to 30% of the sum of minimum of pay in pay band and grade pay corresponding to the pre revised scale of pay from which the pensioner had retired as arrived at with reference to the fitment tables annexed to Ministry of Finance, Department of Expenditure OM No. 1/1/2008-IC dated 30th August, 2008. In the case of HAG and higher pay scales, it shall be 30% of the minimum of pay in revised pay scales given with reference to the fitment tables annexed to the above OM dated 30.08.2008 of Ministry of Finance, Department of Expenditure.

4. A revised relevant table of pre-1996, pre-2006 and post-2006 pay scales/pay bands showing the pension/family pension (at ordinary rates) payable under the above provisions is enclosed for making the payment of revised pension/family pension easy.

5. In pursuance of para 2 above and as shown in column 9 of the annexure, pro rata reduction will be made in the pension revised as such, where the service of the pensioners before 01.01.2016 is less than the maximum service essential for receiving full pension as applicable as per rule 49 of CCS (Pension) Rules, 1972 and it shall not be less than ₹3500/- p.m. in any case.

6. As per the conditions in para 4.1 of this Department O M No. 1/3/2011-P&PW (E) dated 25.05.2012, the enhanced rates of pre-2006 pensioners/family pensioners revised w.e.f. 01.01.2006, shall be stepped up under CCS (Pension) Rules, 1972, Rule 54, Sub Rule (3) (A) in the following manner.

- (a) In the case of those government employees who deceased while in service on or after 01.01.2006 and in respect of whom the enhanced family pension is applicable from the date of approval by Government i.e., 24.09.2012, family pension will be stepped up to 50% of the sum of minimum of pay in pay band and grade pay corresponding to the revised scale of pay in which the pensioner had deceased as arrived at with reference to the fitment tables annexed to Ministry of Finance, Department of Expenditure OM No. 1/1/2008-IC dated 30th August, 2008 of. In the case of HAG and higher pay scales, it shall be 50% of the minimum of pay in revised pay scales as arrived at with reference to the fitment tables annexed to the above OM dated 30.08.2008 of Ministry of Finance, Department of Expenditure.
- (b) In the case of any pensioner who had retired before 01.01.2006 and in respect of whom the enhanced family pension is applicable from the date of approval by Government i.e., 24.09.2012, enhanced family pension will be stepped up to the amount of pension as revised in the conditions of para 2 read with para 5 above. If the pension holder employee deceases before the date of approval by Government i.e., 24.09.2012, pension will be revised notionally under the conditions of para 2 read with para 5 above. However, the amount of revised enhanced family pension shall not be less than the amount of family pension at normal rates as has been revised in the conditions of para 3 above.
7. If the pension/family pension/enhanced family pension calculated as per OM No. 38/37/06-P&PW (A) dated 01.09.2008 is more in comparison to the pension/family pension calculated in the above manner, it (higher consolidated pension/family pension) shall be treated as basic pension/family pension.
8. All other conditions as given in OM No. 38/37/06-P&PW (A) dated 01.09.2008 revised from time to time, shall remain unaltered.
9. These orders will come into force from the date of approval by Government i.e., 24.09.2012. There will be no changes in the amount of revised pension/family pension paid during the period of 01.01.2006 and 23.09.2012 and therefore no arrear amount will be payable on account of these orders.
10. As far as the employees of Indian Audit & Accounts Department are concerned, these orders are issued in consultation with the Comptroller & Auditor General of India.
11. All Ministries/Departments are requested to bring the contents of these orders to the notice of all Controllers of Accounts/Pay and Accounts Officers and attached and subordinate offices under them on high priority basis. All pension disbursement offices are also requested to display these orders on their main notice board for the benefit of the pensioners.
