Subject: Revision of pension of pre-01.01.2006 pensioners.

Sir/Madam,

I am directed to invite your attention to this department OM No. 2/51/2008-1Pension dated 06.02.2015 and clarification issued vide memo No. 2/51/2008/-1Pension, dated 04.05.2015 on the subject cited above, wherein all pre 1.1.2006 pensioner/family pensioner were directed to make request to the department concerned for revision of pension/family pension (as the case may be) in the prescribed format and department will forward the same to Pension Disbursing Authority/Treasury Officers concerned.

- 2. However, instead of following the above instructions, the pensioners/family pensioners are forwarding their applications directly to Finance Department for stepping up their pension/family pension with reference to OM dated 6.02.2015, which is not the correct way for revision of pension/family pension.
- 3. It is again reiterated that the pensioners/family pensioners concerned to submit the requisite proforma issued vide letter dated 04.05.2015 in the department concerned and after verifying the same from the DDO and SAS personnel (posted in the Department), the same may be forwarded to Pension Disbursing Authority/Treasury Officers concerned. The Pension Disbursing Authority/Treasury Officers will step up/revise pension/family pension keeping in view the OM dated 06.02.2015 to the pensioners/family pensioners without any delay.

Finance Department (Pension Branch) has no role to play in fixation of pension/family pension.

- It is, therefore, requested to direct the Head of Office/DDOs/SAS pe (dealing with pension) working under their control, to do the needful immediately.
