इस कार्यालय के पत्र संख्या पेंशन प्राधिकृति/आदेश/के-85/17-18/3130-3164 दिनांक 01.12.2017 एवं 3299-3334 दिनांक 20.12.2017 के अनुक्रम में निदेशालय, पेंशन एवं पेंशनर्स कल्याण विभाग, राजस्थान जयपुर ने पत्रांक प.5(294)निपेवि/नियम/2017/05-75 H दिनांक 02.01.2018 के साथ प्राप्त राजस्थान सरकार, वित्त विभाग (रूल्स दिव्यजन) के जापन क्रमांक एफ, 12(6) एफ.डी./रूल्स /2017 दिनांक 09.12.2017 की प्रति आवश्यक कार्यवाही हेतु प्रेषित की जा रही है। मुख्य बिंदु इस प्रकार है:-

- (1) अधिमूचना दिनांक 30.10.2017 में राजस्थान राज्य पेंशनरो/पारिवारिक पेंशनरो की पेंशन में सातवे वेतन आयोग के अनुसार संशोधन का लाभ 01.10.2017 से दिया गयाथा। जिसे अब पेंशन संशोधन का लाभ 01.01.2016 से देय है।
- (2) दिनांक 01.01.2016 से 30.09.2017 तक के मध्य सेवानिवृत्त/मृत कार्मिको के पेंशन प्रकरणो का संशोधन सम्बंधित विभाग से वेतन निर्धारण के पश्चात प्राप्त होने पर पेंशन विभाग के स्तर से जारी पेंशन परिलाभों की संशोधित अधिकृति के आधार पर किया जावेगा। बैंक अपने स्तर से पेंशन/पारिवारिक पेंशन का संशोधन करने से पूर्व यह सुनिश्चित करले की पेंशनरो को पेंशन/पारिवारिक पेंशन का भुगतान छठवे वेतन आयोग के अनुसार किया जा रहा है अर्थात पेंशनरो को पेंशन/पारिवारिक पेंशन पर को देय महंगाई राहत 119 प्रतिशत की दर से भुगतान किया जा रहा है।
- (3) दिनांक 01.01.2016 से 31.12.2016 तक की अवधि का पेंशन एरियर देय नहीं किया गया है।
- (4) दिनांक 01.01.2017 से 30.09.2017 तक के एरियर का भुगतान 3 किस्तों में 30 प्रतिशत, 30 प्रतिशत एवं 40 प्रतिशत के अनुपात में अगले वर्ष क्रमशः दिनांक 01.04.2018, 01.07.2018 एवं 01.10.2018 को किया जायेगा लेकिन किसी पेंशनरो/पारिवारिक पेंशनरो की मृत्यु के मामले में पेंशन एरियर की पूरी राशि का भुगतान नकद में किया जायेगा।
- (5) न्यूनतम पेंशन/पारिवारिक पेंशन रुपए प्रतिमाह 8,850/- की गयी है एवं दिनांक 01.01.2017 से देय किया गया है तथा 01.01.2017 से 30.09.2017 तक के एरियर का भुगतान तीन किस्तों में बिंदु संख्या 4 में वर्णित दिशा-निर्देशों के अनुसार किया जाना है।

अतः आपसे अनुरोध है कि उक्त आदेश अपने क्षेत्राधिकार के अंतर्गत समस्त कोषाधिकारियों / पेंशन भुगतान अधिकारियों / बैंक शाखाओ को प्रसारित कर भुगतान हेतु निर्देशित करने का श्रम करे तथा प्रति इस कार्यालय को भी प्रेषित करने का श्रम करे।



 5. न्यूनतम पेंशन/पारिवारिक पेंशन रूपये 8850/- प्रति माह की गई है एवं दिनांक 01.01.2017 से इसे देय किया गया है तथा 01.01.2017 से 30.09.2017 तक के एरियर का भुगतान तीन किशतों में बिन्दु संख्या 4 में वर्णित दिशा-निर्देशों के अनुसार किया जाना है।

In continuation to letter no. Pension Auth./Order/K-85/17-18/3130-3164 dated 01.12.2017 of this office, copy of Memorandum No. F 12 (6) F D Rules /2017 dated 09-12-2017 of Government of Rajasthan, Department of Finance (Rules Division) received with letter no. P 5 (294) DPD/Rules/2017/05-75 H dated 02-01-2018 of the Directorate, Pension and Pensioners Welfare Department, Rajasthan, Jaipur is being forwarded necessary action. Main points are as below :

- (1) In Notification dated 30-10-2017, the benefits of revision in the pension of the pensioners / family pensioners of Rajasthan State as per the Seventh Pay Commission was given with effect from 01-10-2017. Now the benefit of pension revision is payable to them w.e.f. 01.01.2016.
- (2) Revision of pension cases of the officials retired/deceased between 01-01-2016 and 30-09-2017 will be done on the basis of revised authority of pension benefits issued at the level of Pension Department on receiving from the concerned department after the fixation of pay. Before revising pension/family pension at their level, the banks may ensure that the payment of pension/family pension to the pensioner is being made in accordance with the Sixth Pay Commission, i.e., the payment of dearness relief payable on pension/family pension is being made to the pensioner at the rate of 119%.
- (3) No pension arrear for the period from 01-01-2016 to 31-12-2016 has been paid.
- (4) Payment of arrears for the period from 01-01-2017 to 30-09-2017 shall be made in three instalment in the ratio of 30%, 30% and 40% in the next year on 01-04-2018, 01-07-2018 and 01-10-2018 respectively, but in case of death of the pensioner/family pensioner the entire amount shall be paid in cash .
- (5) The minimum pension/family pension is Rs8,850/- per month and is payable from 01-01-2017 and the arrear for the period from 01-01-2017 to 30-09-2017 is to be paid in three instalment as per the guidelines given in point no. 4.

Therefore, you are requested that the above mentioned order may please be circulated to all the Treasury Officers/Pension Payment Officers/Branches of Banks under your jurisdiction with the direction to make payment and copy of the same may be sent to this office also.

- Sub :-** Revision of Pension /Family Pension of the pensioners/family pensioners of Rajasthan State, retired /deceased before 01-10-2016 - reg.
- Ref :-** Finance (Rules) Department, Jaipur Memorandum No. F 12(6) F. D./Rules/2017 dated 30.10.2017, dated 05.12.2017 and even no. Memorandum dated 09.12.2017

In continuation to this Department even no. letter no. 1511-80-H dated 08.11.2017 and 1991-2065-H dated 07.12.2017, the Finance (Rules) Department has made amendment in CCS (Pension) Rules, 1996 vide their Memorandum No. F 12 (6) F D Rules /2017 dated 09.12.2017 The main provisions of which are as below :

- (1) In Finance (Rules) Department even no. Notification dated 30.10.2017, the benefits of revision in the pension of the pensioners/family pensioners of Rajasthan State as per the Seventh Pay Commission was given with effect from 01.10.2017, which has been amended and the benefit of pension revision has been given w.e.f. 01.01.2016 vide Memorandum dated 09.12.2017.
- (2) Revision of pension cases of the officials retired/deceased between 01-01-2016 and 30-09-2017 will be done on the basis of revised authority of pension benefits issued at the level of Pension Department on receiving from the concerned department after the fixation of pay. Before revising pension/family pension at their level, the banks may ensure that the payment of pension/family pension to the pensioner is being made in accordance with the Sixth Pay Commission, i.e., *the payment of dearness relief payable on pension/family pension as on 31.12.2015 is being made to the pensioner at the rate of 1.19%.*
- (3) No pension arrear for the period from 01.01.2016 to 31.12.2016 has been paid.
- (4) Payment of arrears for the period from 01.01.2017 to 30.09.2017 shall be made in three instalment in the ratio of 30%, 30% and 40% in the next year on 01.04.2018, 01.07.2018 and 01.10.2018 respectively, but in case of death of the pensioner/family pensioner the entire amount shall be paid in cash .
- (5) The minimum pension/family pension is Rs8,850/- per month and is payable from 01.01.2017 and the arrear for the period from 01.01.2017 to 30.09.2017 is to be paid in three instalment as per the guidelines given in point no. 4.

Therefore, you are requested to ensure compliance of the directions given in Finance (Rules) Department, Memorandum dated 09.12.2017 along with this Department letter no.1511-80-H dated 08.11.2017 and 1991-2065-H dated 07.12.2017 and take necessary action.

Subject:- Revision of Pension of pre-01.01.2016 State Pensioners/ Family Pensioners.

The Governor is pleased to order that the following amendments shall be made in FD Memorandum No. F.12 (6) FD/ Rules/ 2017 dated 30th October, 2017 and as amended by FD Memorandum even number dated 05.12.2017 :-


- (i) The existing figures "01.10.2017" shall be substituted by figures "01.01.2016"
- (ii) The existing figures "30.09.2017" shall be substituted by figures "31.12.2015"
- (iii) The following new para 15 and 16 shall be inserted:-

"15. Non-accrual of Arrears.- Notwithstanding anything contained in these rules, no arrear of Pension and Dearness Relief thereon, shall accrue to a pensioner/family pensioner, between 01.01.2016 to 31.12.2016 (both days inclusive), for the period upto 31.12.2016.

"16. Payment of Arrear.- The arrear to the pensioner/family pensioner for the period from 01.01.2017 to 30.09.2017 shall be payable in three instalments in the ratio of 30, 30 and 40. The first, second and third instalment shall be payable on or after 01.04.2018, 01.07.2018 and 01.10.2018 respectively."

Provided that in case of death of pensioner/ family pensioner, as the case may be, the entire amount of arrear shall be paid in cash during the current financial year 2017-18.



Subject: Amendments in the Rajasthan Civil Services (Pension) Rules, 1996.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Pension) Rules, 1996, namely:

1. These rules may be called the Rajasthan Civil Services (Pension) (Third Amendment) Rules, 2017.
2. These rules shall be deemed to have come into force with effect from 01.01.2016 excepting where otherwise specifically provided.
3. In the said rules –
 - (i) The amendments made vide FD Notification No. F.12(6) FD/Rules/2017 dated 30th October, 2017 with effect from 01.10.2017 shall be deemed to have come into force with effect from 01.01.2016 excepting where otherwise specifically provided.
 - (ii) In clause (a) of sub-rule (2) of Rule 54, the existing words and figures "(the highest pay in the Government is Rs. 77,000/- since 01.01.2006)" shall be substituted by the words and figures "(the highest pay in the Government is Rs.2,18,600/- since 01.01.2016)".
 - (iii) The existing sub-rule (1) of Rule 55 shall be effective from 01.01.2017 instead of 01.10.2017.
 - (iv) the existing clause (i) of Rule 62 shall be substituted by the following, namely: -

"(i) Family pension shall be admissible @ 30% of emoluments subject to a minimum of Rs.8850/- per month and maximum of 30% of the highest pay in the Government (the highest pay in the Government is Rs. 2,18,600/- since 01.01.2016)".
4. **Non-accrual of arrears:** The State Government has revised the pay scales of Government servants with effect from 01.01.2016 with the conditions that no arrears would accrue for the period from 01.01.2016 to 31.12.2016.




Accordingly, on the same lines in respect of Government servants retired / died while in service during the period from 01.01.2016 to 31.12.2016 no arrear of pension shall accrue upto 31.12.2016. Pension / Family Pension calculated on pre-revised pay shall only be payable upto 31.12.2016 and the pension / family pension on revised notional pay and as per the above mentioned amendments shall be payable with effect from 01.01.2017. The Commutation and Gratuity to these Government servants shall not be admissible on the revised notional pay and the amount of Commutation / Gratuity already paid / payable on the pre-revised pay shall be treated as final.

5. **Payment of Arrear.**- The arrear to the pensioner/family pensioner for the period from 01.01.2017 to 30.09.2017 shall be payable in three instalments in the ratio of 30, 30 and 40. The first, second and third instalment shall be payable on or after 01.04.2018, 01.07.2018 and 01.10.2018 respectively.

Provided that in case of death of pensioner/ family pensioner, as the case may be, the entire amount of arrear shall be paid in cash during the current financial year 2017-18.


