In pursuance to Government of India, Finance Department Notification No. 4/1/2017-2FR/23941, Dearness Relief for the Pensioners and Family Pensioners of the Haryana Government on the un-revised Pension and Family Pension who are still drawing the same under 6th CPC w.e.f. 01.07.2019 raising from 154% to 164% (10%).
