Subject:- Grant of Dearness Relief on pension to the Pensioners/Family Pensioners of the Teaching & Non-Teaching staff of Non-Govt. Sponsored/Aided Educational Institutions, etc. under Govt. of West

Bengal with effect from 1/1/2021

In continuation to this office earlier circular No./111/Vol.VII/259/Vol-II/135 dated 19/02/2021, it is stated that Govt. of West Bengal, School Education Department, Planning & Budget Branch in their Memo. No.301-SED-18099140/2020-P 13 SEC-Dept.cit SI dated 16/12/2020 (in pursuance of Finance (Audit) Department Memo No.3490-F(P2) dated 16/12/2020) have sanctioned dearness relief @3% with effect from 1/1/2021 who are drawing pension/family pension at revised rates on the basis of Memo. No. 52/ES/P/P&B/10M-99/2019 dated 14/02/2020 (circulated under this office circular No. Pen. Coordn./259 Vol.II/210 dated 27/4/2020).

The benefit is applicable to the pensioners/family pensioners who are drawing pension/family pension under the scheme D.C.R.B.1981 of West Bengal Non-Govt. Sponsored/Aided Educational Institutions (Primary & Secondary) excluding the pensioners of D.A.getting School.


Payment of Dearness Relief on Pension/Family Pension involving a fraction of rupee shall be rounded off to the next higher rupee.

Other provisions governing grant of dearness relief to pensioners/family pensioners, such as, regulation of dearness relief on pension/family pension during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc., as contained in Finance Department's Memo No. 7533-F dated 06-07-1988 will remain unchanged.

All Pension Disbursing Authorities are, therefore, requested to make necessary arrangements for payment of Dearness Relief @3% with effect from 1-1-2021 on revised basic Pension/Family Pension admissible as per recommendations of the 6th pay commission, to the above categories of Pensioners/Family Pensioners after proper adjustment of amount already paid.
