G.O. Ms. No.12 dated 09.04.2018 of the Chief Secretariat(Health), Government of Puduchery.

With reference to the subject mentioned above, I am to state that as per the terms and conditions 13 of the GO cited under reference, the pensioners/Family Pensioners who have opted under the Contributory Medical Benefit Scheme, are required to submit representation about issue/discrepancies/loss of Identity Card to M/s. New India Assurance Company(M/s. NIAC), Puducherry through the Directorate of Accounts and Treasuries(DAT), Puducherry for redress and the Identity Cards of those Pensioners/Family Pensioners who die in harness, shall have to surrender their Identity Card to M/s. NIAC, through the DAT.

Accordingly, the Pensioners/Family Pensioners who have enrolled themselves as beneficiary under the scheme may be advised to submit the representation to DAT for necessary action and also to surrender the Identity Card of the deceased Pensioner/Family Pensioner to Directorate of Accounts and Treasuries immediately by the member/relatives of the family as stated above.
